Sub: Administrative Approval for 21 (twenty one) schemes bearing scheme ID Nos. IW/CSP-184/2016-17 to IW/CSP-204/2016-17 out of Core State Plan Budget Provision of this Department, subordinate to Demand No.32 during the current financial year of 2016-17.

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for 21 (twenty one) schemes, having an aggregate estimated cost of ₹2755.88 lakh (Rupees Two seven five five point eight eight lakh) only under Core State Plan Budget Provision of Irrigation & Waterways Department, subordinate to Demand No. 32, as shown in the Annexure to this Order during the current financial year of 2016-17 provided,

- a) That all the Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
- b) That the projects do not overlap with any central sector scheme or state sector scheme undertaken by this/other Department of the State Government.
- c) That the tender issuing authority/tender accepting authority shall ensure the right to take up the work on the land in question like NoC from the respective Local Bodies (Ref. FD Notification No. 10184-F(A-II) dated 13.12.2012).

This order issues with the concurrence of the Financial Advisor, Irrigation & Waterways Department vide his **U.O.** Nos. 217 to 237 Dated 16.11.2016 as mentioned against each of the said 21 schemes under Column 9 & 10 of the <u>Annexure</u> to this Order.
