Sub: Revised Administrative Approval for the scheme "Reconstruction of RCC bridge at Joymolla over river Julkia (ch. 120.00) within G.P Beraberi in Block & P.S Singur, District Hooghly" bearing Scheme ID No. IW/CSP-170/2015-16 out of Core State Plan Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during 2016-17.

The undersigned is directed to say that administrative approval of original scheme was accorded vide this Departments No. 345(3)-IB dated 22.01.2016 with the concurrence of Financial Advisor vide his U.O No. 368 dated 22.01.2016 at an estimated cost of ₹ 152.19 lakh out of Core State budget of this Department in the FY 2015-16.

Further to above, it was reported by the concerned Chief Engineer vide his No. 664-CI/6E-27/16(D) dated 18.11.2016 that the main reason for modification in design is attributed to inadequacy of vantage considered in the original scheme to accommodate huge discharge in a short spell mainly during monsoon. Subsequently, the design has been modified in order to cater the said discharge and the revised estimate has been framed after due incorporation of such modifications in design.

Now, the undersigned is directed to accord Revised Administrative Approval of the scheme "Reconstruction of RCC bridge at Joymolla over river Julkia (ch. 120.00) within G.P Beraberi in Block & P.S Singur, District Hooghly" under Hooghly Irrigation Division, I&W Dte. at a revised cost of ₹ 191.86 lakh (Rupees One nine one point eight six lakh) only, under Core State Plan Budget, Subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2016-17.
