**Sub: Administrative Approval of scheme of "Construction of Check Dam over Jamunajore at Mouza - Bhurudanga in Block - Ranibundh, District - Bankura" having scheme ID:RKVY-04/17-18, out of 'Rashtriya Krishi Vikas Yojana' (RKVY) under State Plan (Voted) Budget of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during 2017-18.**

The undersigned is directed to say that State Level Sanctioning Committee (SLSC) on RKVY approved an outlay for a sum of **₹10.10 Crore** under RKVY (Normal) during 2017-18 in favour of this Department on 09.03.2017 communicated vide No.437-Nab./9M-41/2017 dated 24.03.2017 of Joint Secretary, Agriculture Department, Govt. of West Bengal which includes 4 (Four) Nos of new schemes of construction of check dam in the District of Bankura, included in the State Irrigation Plan (SIP) of 2017-18 and District Irrigation Plan (DIP) of Bankura District of 2017-18 under PMKSY.

Annual outlay for I&WD under RKVY (Normal) during 2017-18 has been approved at **₹10.10 Crore**, out of which **₹4.00 Crore** has been earmarked for taking up new schemes during 2017-18. Spillover amount of **₹7.50 Crore** against the approved four new schemes has been phased in the next financial year.

A total of 3 nos schemes, out of above mentioned total 4 nos of schemes under 'Rastriya Krishi Vikas Yojana' (RKVY), have already been administratively approved vide I&WD G.O.No. 88-IB dated 24.05.2017 and G.O.No.290-IB dated 24.08.2017 at an aggregated cost of ₹919.47 Lakh. The balance scheme of **"Construction of Check Dam over Jamunajore at Mouza - Bhurudanga in Block - Ranibundh, District - Bankura"** was approved at an estimated cost of **₹599.64 Lakh** at 16<sup>th</sup> SLSC meeting held on 11.09.2017.

Now, the undersigned is directed to convey the sanction of the Governor towards Administrative Approval for the scheme of **"Construction of Check Dam over Jamunajore at Mouza - Bhurudanga in Block - Ranibundh, District - Bankura"**, under **Kangsabati Canal Division No.II**, having scheme ID: **RKVY-04/17-18**, out of total 4 (Four) Nos of new schemes under 'Rastriya Krishi Vikas Yojana' (RKVY) at an estimated cost of **₹599.64 Lakh** under State Plan Budget of this Department subordinate to Demand No.32 as contained in B.P No.20 during 2017-18.
