Sub: Cancellation of administrative approval of two schemes originally approved under Core Plan voted budget of this Department during the current financial year 2017-18 bearing ID. No. IW/CSP-292/2017-18 & IW/CSP-298/2017-18

Administrative Approval was accorded to the following 2 (two) schemes vide this Department Memo No. 343-IB/ IW/P/IB-CSP-60/2017-18 dt. 21.09.2017 out of Core State Plan Budget of Irrigation & Waterways Department under Demand No. 32 during the current financial year of 2017-18.

- 1. Fencing and beautification along left bank of DWF Channel from Dr. B. R. Ambedkar Bridge [EM Bypass crossing] to Arupota Bridge for a length of 345.00 m within KMC Ward No. 108, P.S. Anandapur, South 24 Parganas (Scheme ID: IW/CSP-292/2017-18) Administratively approved cost: Rs. 59.45 lakh
- 2. Construction of boundary wall along the left bank of the SWF Channel along with aesthetic improvement of road flank of Basanti Highway from Ch 240.00 at Bantala to Ch 333.00 at Bamanghata for a length of 2.83 KM in P.S.- Kolkata Leather Complex (Scheme ID: IW/CSP-298/2017-18) Administratively approved Cost: Rs. 83.14 lakh

As per his report, West Bengal Highway Development Corporation under PWD, GoWB has already commenced widening of existing road and as such the above two works cannot be practically executed in the field.

In the above context, the undersigned is directed to convey that the Administrative Approval of the above 2 (two) schemes are hereby withdrawn and may be treated as cancelled under Core State Plan of Irrigation & Waterways Department originally accorded during the current financial year of 2017-18.
