The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval of Rs. 1165.50 lakh (Rupees One one six five point five zero lakh) only relating to the project "Development and Construction of Bituminous road 3.682 km including construction of cross drainage structures, Boundary Wall for a length of 4.081 km, Main Entry Gate, Security Room and landscaping and renovation of existing inspection Bungalow in connection with infrastructural Development of River research Institute at Haringhata Central Laboratory, Mohonpur, Nadia" under the Executive Engineer, Sundarban Delta Project, River Research Institute, I & W Dte. out of Core State Plan (Voted) Budget of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2017-18, provided,

- b) That the projects do not overlap with any central sector scheme or state sector scheme undertaken by other Departments of the State Government.
- c) That the Administrative Department shall ensure that the executing authority has the authority to take up the work on the land in question like NOC from he respective Local Bodies etc. (Ref- FD Notification No. 10184-F(A-II) dt. 13.12.2012).
