Sub: Administrative Approval for 15 (fifteen) new projects bearing ID No. IW/CSP-520/2018-19 to IW/CSP-534/2018-19 under Capital Outlay of 'State Development Schemes' voted Budget for 2018-19 of this Department subordinate to Demand No. 32 contained in B.P No. 20.

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for 15 (fifteen) projects bearing ID No. IW/CSP-520/2018-19 to IW/CSP-534/2018-19 at an aggregate estimated cost of Rs. 4791.16 lakh (**Rupees Four Seven Nine One point One Six lakh**) only as detailed in the Annexure to this Order under Capital Outlay of 'State

Development Schemes' voted Budget for 2018-19 of this Department subordinate to Demand No. 32 contained in B.P No. 20 on following terms & conditions:

- a) That all the Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
- b) That the projects do not overlap with any central sector scheme or state sector scheme undertaken by other Departments of the State Government.
- c) That the Administrative Department shall ensure that the executing authority has the authority to take up the work on the land in question like NoC from the respective Local Bodies etc (Ref: FD Notification No. 10184-F(A-II) dated 13.12.2012).
- d) That special precaution should be taken in respect of works to be undertaken on Ex-zamindary land with prior intimation to the P & RD Department as decided in DSC meetings.

This order issues with the concurrence of the Financial Advisor, Irrigation & Waterways Department vide his **U.O. Nos. 375 to 388A Dated 05.11.2018** as mentioned against each of the said 15 schemes under Column 9 & 10 of the Annexure to this Order.
