Administrative Approval was accorded to the following 2 (two) schemes vide this Department Memo No. 223(7)-IB/IW/P/IB-SDS-15/2018-19 dt. 02.07.2018 out of State Development Schemes Budget of Irrigation & Waterways Department under Demand No. 32 during the current financial year of 2018-19.

- 1. Improvement of 11 No. of Wooden Bridges at Blocks- Contai I, II & III, Patashpur -II, Egra and Patashpur of Purba Medinipur (Scheme ID- IW/CSP-342/2018-19) Administratively Approved Cost- Rs. 116.33 Lakh.
- 2. Improvement of 50 No. of Sluices at different G.P. areas of District- Purba Medinipur under Blocks- Contai I, II & III, Patashpur -II, Egra- II, P.S. Contai, Maisda, Egra and Patashpur, District- Purba Medinipur (Scheme ID- IW/CSP-345/2018-19) Administratively Approved Cost- Rs. 106.67 Lakh.
