Sub: Revised Administrative Approval for the project 'Protection work at eroding right embankment of River Hooghly for a length of 650.00 M of Ghusury under Ward No. -1 of Howrah Municipal Corporation P.S. Malipanchghara, District-Howrah' under Howrah Irrigation Division bearing scheme ID No. IW/CSP-155/2017-18, out of State Development Schemes (Voted) Budget of this Department, subordinate to Demand No. 32, as contained in B.P No. 20 during 2018-19.

The undersigned is directed to say that Administrative Approval for the Apportioned Cost of ₹. 369.56 lakh being the 50% of the total project cost of the above scheme was accorded vide this Department's No. 60-IB/IW/P/IB/CSP-16/2017-18 dt. 12.05.2017 with the concurrence of Financial Advisor vide his U.O No. 95 dated 08.05.2017 out of Core State Plan (now State Development Schemes) Budget of this Department in the FY 2017-18.

It was assured by the Howrah Municipal Corporation under UD & MA Department, GoWB, that the balance 50 % of the total project cost of ₹. 739.11 lakh would be borne by them. Since no response is received from the Howrah Municipal Corporation regarding release of their apportioned amount and the work has already been completed long back, the matter was under consideration for some time past for funding the entire cost of the project by this Department.

Now, the undersigned is directed to convey the formal Revised Administrative Approval of the project 'Protection work at eroding right embankment of River Hooghly for a

length of 650.00 M of Ghosury under Ward No. -1 of Howrah Municipal Corporation P.S. Malipanchghara, District- Howrah' under Howrah Irrigation Division bearing scheme ID No. IW/CSP-155/2017-18 at a revised estimated cost of ₹. 739.11 lakh (Rupees seven crore thirty-nine lakh eleven thousand) only, under State Development Schemes Budget, Subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2018-19.
