Reference:- 1. This Department's Administrative Approval Order No.-227-I/I-4M-08/2016 (pt) dated 01.06.2017

- 2. Agreement signed between the Director dam safety Organization, I&W dte and the WAPCOS ltd on 22.08.2017 for the above stated consultancy work on safety audit.
- 3. Memo no.-1330-CI dated 13.03.2020 of the Chief Engineer (D&R), I&W dte dated 13.03.2020 proposing accordance of revised Administrative Approval on the above stated consultancy work on safety audit.

The Administrative Approval for the consultancy work namely "Conducting safety audit for all categories of dams, barrages including pick up barrages and major category RCC/Steel/Composite bridges through WAPCOS Ltd" was accorded by the Department in June-2017 vide memo no. under reference-1. The Director, Dam Safety Organization, being the Nodal officer for the Safety Audit assignment, entered in to an agreement with WAPCOS Ltd on 22.08.2017 to get the consultancy job done through WAPCOS Ltd at a total consultancy charge of rs. 9,86,80,385 (excluding applicable taxes) which embodies detail scope of work, payment terms and other terms and conditions.

2. The Chief Engineer, Design & Research, I&W Dte submitted a proposal of revision of some rates of the above stated consultancy work owing to quantitative increase of certain tests/anslysis associated with those items, culminating into an enhancement in the overall consultancy charge to rs. 10, 78, 84,000 which along with applicable G.ST stands at Rs. 12,73,04,000/-.

- 3. Accordingly, the proposal of accordance of revised Administrative Approval was sent to Finance Department, Govt of West Bengal to obtain their concurrence and the same has been accorded by the Group-F of the Finance Department on 22.11.2020.
- 4. In view of above, the undersigned is directed to inform that the Governor is pleased to accord revised Administrative approval on the above stated consultancy work at a revised cost of Rs. 12,73,04,000/- (Rs twelve crores seventy three lakhs four thousand only) (including 18% G.S.T) to accommodate the revision of rates and additional works mentioned in the memo under reference-3.
