1. It is requested that the index plan of the existing bank line be prepared on a google map. Moreover, one ADCP survey be made at the same location just after one year from the day of completion of the work to observe the effect of this work on the presently damaged bank of the river and be kept as record and reference in future study.
2. This is issued subject to judicious selection of scheme and ensuring that the scheme is not implemented under any other fund of the Government.
3. The concerned C.E. is to submit the timelines for the action plan starting from the issuing tender till the completion of work, before issuing the tender.
