Sub: Procedure to be followed in dealing with the medical reimbursement bills of an existing or retired Govt. employee and / or his beneficiary under West Bengal Health Scheme, 2008.

Please find enclosed a copy of I&W. Department's Memorandum No.1893-IE-2M (HS)-185/13 (Pt) dated 19-07-2016.

The following points may please be noted in settling the claims for reimbursement of the cost of medical attendance and treatment in respect of an existing or retired Govt. employee and / or his beneficiary:

- (i) The application made for reimbursement of the cost of medical attendance and treatment shall be processed by the Department or the Directorate or the Office, as the case may be, in accordance with the provisions of Notification No. 4201 –F (MED) dt. 13-08-2014 of Finance Department, Audit Branch, Medical Cell (copy enclosed) in the following manner:
- a) For Indoor Treatment up to Rs.50,000/- and for OPD Treatment up to Rs. 5,000/-, the Head of Office (below the rank of Director) will issue sanction order for the cost of medical attendance and treatment.
- b) For Indoor Treatment up to Rs.1.00 lakh and OPD Treatment up to Rs. 10,000/-, the Head of Directorate will issue sanction order for the cost of medical attendance and treatment.
- c) For Indoor Treatment above Rs.1.00 lakh and OPD treatment above Rs.10,000/-, the Departmental Secretary will issue sanction order for the cost of medical attendance and treatment.

For the cases falling under (b) and (c) above, all the regional offices under this Department shall, henceforth forward directly the application for claim under the aforesaid scheme along with the supporting documents from their respective offices where their D.D.O.s are located, to the Department or the Directorate (as is applicable). For this purpose, those offices should provide the following details while forwarding the claims to their respective higher offices:

- 1) Designation of the concerned D.D.O. (with D.D.O. Code).
- 2) Name of the concerned Treasury / Pay & Accounts Office with full postal address.
- 3) Budget Head of Account for reimbursement under W.B. H.S., 2008.

MEMORANDUM

At present, in case of claim amount under the West Bengal Health Scheme' 08, made by the employees/pensioners of the regional offices under this Department, exceeds Rs.50,000/- for indoor treatment or Rs.5,000/- for OPD treatment, as the case may be, this Department or its Directorate use to issue approval G.O. for reimbursement under the said scheme, and the respective offices where their DDOs are located, are asked to issue matching sanction order in this respect under the prevailing system. Henceforth this Department or Head of its Directorate will issue sanction order regarding the same. In this context, all the regional offices under this Department may now forward directly the application for claim under the aforesaid scheme along with supportive documents from their respective offices where their DDOs are located, to this Department or its Directorate (as where applicable under provision of Clause-13 of Finance (Audit) Department Notification No. 7287-F dated 19/09/2008 read with their another Notification No. 4201-F(MED) dated 13/08/2014). For this purpose, those offices should provide the following details:

- 1) Designation of DDO
- 2) Treasury Name with full postal address
- 3) Budget Head of Account for reimbursement under WBHS'08

Further, in case of permission of treatment under the said scheme or any other similar kind of matter where the approval or opinion of the Secretary of this Department or the WBHS Authority is required, the respective matter now may be forwarded by such regional office directly to this Department for ensuring quick proceeding of the same.

However, for every aforesaid occasion, the regional offices under this Department should forward information of the same to their respective higher offices. Any previous notification, memorandum or circular issued in this respect by this Department or its Directorate which contradicts the provision of the instant Memorandum, is deemed to be treated void.

This will take immediate effect.
