### CIRCULAR

In pursuance of Finance Department's (Audit Br.) - Severe illness and absence continuing prior to 24<sup>th</sup> September, 2018.
- Employees who had been on Child Care Leave, Maternity Leave, Medical Leave and Earned Leave sanctioned prior to 24<sup>th</sup> September, 2018. (Specific reasons with documentary proof will have to be furnished in each case).

The absence of employees on those dates will be treated as '*dies-non*' and no salary would be admissible unless such absence is covered by the grounds as mentioned in said orders.
