Apropos above it is stated that the entry duly made in the Original Service Book of Sri Shyamu Rasaily, U.D.C., I&W Dte. in the matter of his refusal of promotion to the post of Head Clerk has been checked, verified and found correct.


In this context, it is also observed from the Service Book that Sri Rasaily was awarded the benefit of 25 years' service under MCAS'01 with effect from 15.7.2017 but prior to such grant of non-functional elevation to him from his end, he refused the promotion to the post of Head Clerk, vide his Memo No. 89/3P-18, dated 27.1.2017.


In consequence of such willful refusal of promotion to the post of Head Clerk, he will not be entitled further to the benefit of 25 years' service in terms of Memorandum No. 9120-F, dated 13.11.2000, of the Finance Department ( Audit Branch).

As such the benefit of 25 years' service under MCAS'01 awarded to him earlier shall be cancelled and overdrawal amount is to be recovered forthwith from the salary of the incumbent concerned positively.
