Ref.: 1. This office memo no. 3282(120)-CIE/7P-03/17 dated 30.01.2019, 4192-CIE dated 13.06.2019 and Memo No. 5652- CIE date 17.12.2019 and his memo no. 37/3E-14 date 08.01.2020.

This is to inform him that Sri Ramendra Misra, Surveyor Grade- I was promoted to the post of Head Surveyor with effect from 01.05.15 in the Pay Band- 3 of Rs. 7,100/- Rs. 37,600/- with Grade Pay Rs. 4,100/- vide this office Memo No. 3282(120)-CIE/7P-03/17 dated 30.01.2019. In that order it was clearly stated a) to record the matter of refusal of promotion (if any) in the Service Book of the concerned employee and send the same after recording the matter to this office for necessary verification in this regard. b) to take action in terms of Finance Department, Audit Branch No. 9120-F dated 13.03.2000 and No. 6042-F(P₂) dated 07.11.2009 in connection with allowing the benefit under MCAS'01 in case of refusal of promotion strictly.

After issuing the above promotion order in respect of Sri Ramendra Misra, Surveyor Grade-I, he was repeatedly requested with this office Memo no. 4192-CIE/7P-03/17 dated 13.06.2019 and Memo No. 5652-CIE//7P-03/17 date 17.12.2019 to intimate this office regarding refusal of promotion of Sri Mishra, Surveyor Grade-I and to take action accordingly. But no communication from his end has been received by this office till date.

It is evident from his memo along with its enclosures under reference that entry in connection with the matter of such refusal of promotion has been made in the original service book of Sri Mishra after passing a long time from the issuance of promotion order on 30.12.2019. It is also come to know from his memo under reference that it was not possible to send the original service book of Sri Mishra, Surveyor Grade -I to this office due to implementation of WBS(ROPA) Rules, 2019. But till date no action has been received from his end.

Now he is hereby directed to let this office know the following points:

- 3. Reason behind the silence in this matter from the issuance of promotion order and after implementation of WBS(ROPA) Rules,2019 in favour of Sri Ramendra Misra, Surveyor Grade-I.
- 4. Whether Sri Ramendra Misra, Surveyor Grade- I was allowed 3rd higher scale of Pay after completion of 25 (twenty five) years of service with effect from 04.02.2017. It seems that the same has been withdrawn from his end in terms of Finance Department, Audit Branch No. 9120-F dated 13.03.2000 and No. 6042-F(P₂) dated 07.11.20 9 and in consonance with this office memo nos. under

reference in connection with allowing the benefit under MCAS'01 in case of refusal of promotion strictly.

Under the circumstances stated above he is directed to complete all actions within 15(fifteen) days from issue of this letter, positively.
