> Sub.: Promotion to the post of Head Surveyor in respect of Sri Ramendra Narayan Misra, Surveyor Grade- I under I & W Directorate.

Ref.: 1. This office memo no. 3282(120)-CIE/7P-03/17 dated 30.01.2019, 4192-CIE dated 13.06.2019 Memo No. 5652- CIE date 17.12.2019 and Memo No. 3558 - CIE date 13.03.2020. His memo no. 37/3E-14 date 08.01.2020 and 376/3E-14 dated 19.03.2020.

He was repeatedly directed to withdraw the 3<sup>rd</sup> higher scale of Pay after completion of 25 (twenty five) years of service under MCAS'01 with effect from 03.02.2017 in respect of Sri Ramendra Narayan Misra, Surveyor Grade- I withdrawn from his end in terms of Finance Department, Audit Branch No. 9120-F dated 13.03.2000 and No. 6042-F(P2) dated 07.11.2019 and in consonance with this office memo nos. under reference in connection with allowing the benefit under MCAS'01 in case of refusal of promotion strictly.

But it is very surprising that the original service book of Sri Mishra, Surveyor Grade -I has been sent to this office only for verification from his end vide his memo 376/3E-14 dated 19.03.2020. The ultimate action as stated above has not yet been taken from his end even after repeated direction from this end.

Under the circumstances stated above he is once again directed to withdraw the 3<sup>rd</sup> higher scale of Pay after completion of 25 (twenty five) years of service under MCAS'01 with effect from 03.02.2017 in respect of Sri Ramendra Narayan Misra, Surveyor Grade- I from his end in terms of Finance Department, Audit Branch No. 9120-F dated 13.03.2000 and No. 6042-F(P2) dated 07.11.2019 immediately. In this context, this office memo no. 2022-CIE dated 09.01.2018 is hereby cancelled. He is directed to refix his pay wef 03.02.2017 at first under WBS(ROPA) Rules 2009 and calculate the overdrawal amount immediately. He is also directed to refix his pay under WBS(ROPA) Rules 2019 and calculate the overdrawal amount immediately. The entire refixation should be completed before granting him annual increment w.e.f 01.07.2020 if he is otherwise eligible for increment. The total overdrawal amount should also be recovered from his salary before his retirement.

He is once again directed to comply with the instructions stated above failing which action may be taken against him by the appropriate authority.

The original service book of Sri Misra, Surveyor Grade- I is returned herewith with the direction to resend the same after recording the withdrawal of 3<sup>rd</sup> higher scale of Pay after completion of 25 (twenty five) years of service under MCAS'01 and refixation of his pay within 31st July,2020 strictly.
