Agenda: Proposal for recommendation of 06 (Six) new schemes (03 schemes costing above Rs 1.50 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

1. DPR of 06 schemes were discussed during the meeting under Calcutta Drainage Outfall Division, EE-I, Lower Damodar Construction Division, I&W Dte.

- 2. The scheme (under sl. 1) for de-siltation of Suburban Head Cut Channel of Calcutta Drainage Outfall Division ,being above Rs. 5 crore values, has been technically recommended by the Departmental Technical Committee of Chief Engineers in their 284<sup>th</sup> meeting held on 08.12.2021. The scheme has been recommended by the DSC with some modification in the name of work as well as zone of work. A length of 500 mtr at initial part of canal has been omitted in the present scheme, as explained by the Chief Engineer [South] due to some administrative reason.
- 3. The scheme (under sl. 2) for de-siltation of Balitikuri khal of Lower Damodar Construction Division, being above Rs. 5 crore values, have been technically recommended by the Departmental Technical Committee of Chief Engineers in their 242<sup>th</sup> meeting held on 26.11.2019 The scheme has been recommended by the DSC with some modification in the name of work.
- 4. Remaining 04 schemes, (under sl.3,4,5,6) have been technically recommended by the Directorate Level Technical Committee in their 22<sup>nd</sup> Meeting held on 24.01.2022. All these 04 schemes (underSl. 3,4,5,6) have been recommended by the DSC with some modification in name of work for sl. no. 3.
- 5. Finally, 06 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22. However, three of the scheme (under Sl. 1, 2, 6) needs to be submitted to the Finance Department for administrative approval and the remaining 03 (three) schemes ( under Sl 3, 4, 5) may be approved under delegated Departmental power for administrative approval, each costing within Rs. 1.5 crore.
- 6. It has been directed to explore some new/ non-conventional technique for periodical accumulation & collection of debris / floating mass from drainage channels at few strategic points within the jurisdiction of Chief Engineer(South) to avoid any afflux followed by over topping of drainage channels at upper reach during monsoon.
- 7. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in DSC meeting.
