You are therefore requested to collect the Data's of all Engineer Officers from the rank of the Assistant Engineer to the Superintending Engineer at prima facie, posted at your Office, Circle Offices, Division and Sub Division Offices under your jurisdiction & compile it at your end and send it by mail to email2debashis1@gmail.com . You are also requested to submit the Hard copy of the same to the Secretary, Irrigation & Waterways Department simultaneously.

It is further requested to maintain a separate excel sheet for an individual rank. The name(s) of the Circle/Division/Sub-Division under your jurisdiction which is/are now lying vacant may also be mentioned. In such case, a 'VACANT' remarks may be mentioned against the name of the said Circle/Division/Sub Division.

A specimen copy of proforma for collection of Data of the officers is annexed herewith and a soft copy of the same is also being mailed to your official email.

The compiled Data must reach this end under the signature of the Chief Engineer concerned only within 28th September, 2022 from the date of issuance of this letter.
