**Subject : Permission to invite e-NIT against 36 nos prioritized works within Dist : North 24 Parganas, South 24 Parganas, Purba Burdwan, Paschim Medinipur, Dakshin Dinajpur and KMC area**

With reference to the above subject , the undersigned is directed to convey the consent of the Department to invite e-NIT against 36 nos prioritized works within Dist : North 24 Parganas, South 24 Parganas ,Purba Burdwan, Paschim Medinipur, Dakshin Dinajpur and KMC area, stated in the list of works Annexed herewith, by observing following norms :

a)Considering the urgency ,the tenders may be invited for the works , embodied in the list Annexed. However , the concerned Chief Engineers need to ensure that the proposed bridge constructions are as per the bridge construction policy of the Department . After tendering , the cost and name of these schemes are to be communicated to the Department to give a firm idea of the exact location of the works and financial involvement there for. However LOA / Work Orders can only be issued after obtaining formal Administrative Approval against these works.


b)The Technically Sanctioned D.P.Rs of the schemes are to be submitted to the Department at the earliest after due recommendation of the Directorate Level Technical Committee /Departmental Technical Committee of Chief Engineers of I&WD to process for Administrative Approval through DSC meeting within FY 2022-23 budget provision , if the budget permits . Otherwise Administrative Approval may be processed within the budget provision of FY 2023-24

c) Simultaneously, the schemes under appraisal of Directorate Level Technical Committee / Departmental Technical Committee of Chief Engineers of I&WD are to be firmed up as per the advice of Directorate Level Technical Committee / Departmental Technical Committee of Chief Engineers of I&WD. If after checking of the Directorate Level Technical Committee / Departmental Technical Committee of Chief Engineers of I&WD such project cost varies from that considered in the tender, the tender may be cancelled and reinvited with the revised cost. Such Technically Sanctioned revised DPRs are to be submitted to the Department to process for Administrative Approval.

d) The Chief Engineer (South) is being requested to send the DPR of the scheme "Construction of Concrete Bridge at Dholtikaria over Katakhal Khal Dist- South 24 pgs", for onward submission to the P&R Dept. for consideration to execute through WBSRDA within the budget provision of that Department. However, one proposed scheme namely "Re-excavation of Adi Ganga Khal, Block-Sonarapur. Dist- South 24 pgs" may be considered under the upcoming ADB funded project.


