The undersigned is further directed to say that the Finance Department, Govt. of West Bengal vide U.O No. Group P2/2024-2025/0443 dated 21.08.2024, has been pleased to take the instant matter as a special case and in relaxation of normal rules, treated such appointments on promotion of those 78 promotee LDCs as full accompli subject to the following conditions:

- Those 78 promote LDCs shall have to undergo the mandatory 'Typing Test' conducted by the ATI,WB, and their future increments shall be withheld till they pass such test.
- II) Their seniority in the post of LDC and restoration of increment shall be made effective from the day following the last date of the test in which they are declared to have passed.
- III) The case of Gr.D or Non-technical Gr.C, if any, who had fulfilled the condition for promotion to the post of LDC but were not considered for such promotion while issuing promotion orders ibid, have to be considered separately.

If he/she is not willing to accept the promotion he/she will have to inform in writing to the respective officer, where he is posted now within one month from the date of this order.
