The APRs of the all the employees, who are posted in the Division offices/Revenue offices, should be sent through concerned Superintending Engineers.

The concerned Superintending Engineers being the appointing authority of Group-D employees are hereby requested to send Vigilance clearance report of Group-D employees in a sealed cover.

He/She is requested again to bring this instruction to the notice of all regular qualified Group-D and Non-technical Group-C (below LDC) employees who have passed Type test conducted by NSATI, WB on or before 01.07.2020 under his/her control in order to point out the error or omission in the previous list (103 nos. employees).

The concerned officers are directed to send all the APRs, documents and vigilance clearance report within **10(ten)** days from the issue of this letter. No further representation/prayer to include the name in the list who have passed Type test conducted by NSATI, WB on or before 01.07.2020, will be entertained after **10(ten)** days from the issue of this letter.
