Agenda: Proposal for recommendation of 12 (twelve) new schemes (10 nos costing below Rs 1.50 crore) and one additional scheme related to overcome drainage & water logging issues around BAPL project at Andal for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

1. DPR of 09 no. of schemes included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021 were initially placed

in the meeting. Three [03] more schemes were discussed during the meeting under Malda Irrigation Division, Berhampur Irrigation Division and EE-I, Lower Damodar Construction Division of I&W Dte.

- 2. Out of 12 schemes, 10 no. schemes (under sl 1 , 2, 3, 4, 5, 6, 7, 8, 11, 12) technically recommended by the Directorate Level Technical Committee in their 24th Meeting held on 31.01.2022 , 01 scheme (under sl 9) technically recommended by the Directorate Level Technical Committee in their 25th Meeting held on 07.02.2022 ,01 scheme (under sl 10) technically recommended by the Directorate Level Technical Committee in their 21th Meeting held on 19.01.2022. All of those 12 schemes [under sl 1 to sl 12] have been recommended by this DSC.
- 3. One additional scheme related to overcome drainage and water logging issues for housing and industrial area developed around BAPL project ,in block: Andal, Dist: Paschim Bardhaman under Damodar Headworks Division ,being above Rs. 5 crore values, has been technically recommended by the Departmental Technical Committee of Chief Engineers in their 287th meeting held on 20.01.2022. This original scheme has been splitted in two parts ,considering land acquisition issues in part-II by other Department, and submitted by the Chief Engineer [West]. This has a reference to the RoD of the Principal Secretary to this Department dated 20.12.2022, in compliance to the direction of the Chief Secretary to the Government of West Bengal. Now part-I of the original scheme (under sl 13) has been recommended by the DSC with some modification in the name of work.
- 4. Finally, 13 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
- 5. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
