The undersigned is directed to inform him that 56 out of total 57 Data Entry Operators (DEOs) provided by Webel Support Multipurpose Service Co-operative Society Ltd., who have joined at the office of Director of Personnel & Ex-officio Chief Engineer, Irrigation & Waterways Directorate on 29<sup>th</sup> February 2016, have reported for duties in the respective offices of this Department as per instruction of the said Chief Engineer. As such, their period of engagement for one year may be reckoned from 1<sup>st</sup> March 2016. A complete list of candidates, along with their places of posting is furnished herewith as <u>Annexure-I</u>. Since Model of Conduct has since been imposed in the State in connection with the ensuing General Election of the Legislative Assembly, no new DEO needs to be provided for the office of Revenue Officer, Damodar Revenue Division No.II at Durgapur (SI.27 of Annexure-I) at this stage.

2. As already been agreed upon in this Department Memo No.462-IE/IW/N/IE-9A-10/2013 dated 11<sup>th</sup> February 2016, consolidated pay for each operator shall be ₹ 11,000.00 per month and following charges shall be additionally paid / reimbursed to WTL by this Department, subject to the condition of making necessary contribution to P.F. & E.S.I.C. at prescribed rate and depositing the deduction made by WTL from the individual operators together with own contribution, to the concerned Authorities of P.F., E.S.I.C. & Service Tax.

3. Concerned controlling officers of this Department are being directed to submit 'Absentee Statement' of the DEOs of the previous month in the format enclosed as <u>Annexure-II</u>, within first two working days of the next month, directly to WTL through e-Mail (attn.iww@gmail.com). Such operators will be required to provide services for at least all the working days in a month (excluding Saturday, Sundays and Government Holidays) and up to a maximum of 26 (Twenty Six) calendar days in a month, to become eligible for full month's payment.

4. DEOs may be required to be replaced in cases of insubordination, improper behavior, inefficiency, negligence of duties and long absence.

5. As already been agreed upon in this Department No.493-IE/IW/N/IE-9A-10/2013 dated 15.02.2016, one month advance payment in respect of the DEOs actually joined for duties in the respective workplaces, would be allowed to WTL, on submission of bill to the Executive Engineer, Calcutta Drainage Outfall Division, Irrigation & Waterways Directorate, having office at 6<sup>th</sup> Floor, Jalasampad Bhaban, Block-DF, Sector-III, Bidhannagar, Kolkata 700091, who has been declared as Drawing & Disbursing Officer (DDO) for this purpose, vide this Department No.462-IE/IW/N/IE-9A-10/2013 dated 11<sup>th</sup> February 2016. Subsequently, bills with authenticated absentee statements would have to be submitted to the said DDO from April 2016 onwards. Advance amount, paid initially may be adjusted in the last month of the contract period, which is for 1 (One) year and may be reviewed thereafter.

6. The charge will be debited out of Non Plan Budgetary provision of this Department, under the Head of Account: "2701 - 03 - 105 - NP - 001 - 00 - 00" in the current financial year of 2015-16. Appropriate head of account for the next financial year would be intimated in due course.
