Memorandum

It has been decided by the Government in the Irrigation & Waterways Department, that henceforth all **Item Rates** for works including the specifications thereof required for framing of all categories of estimates/DPRs would have to be compulsorily taken from the latest Schedule of Rates (SoR) of Public Works Department, Government of West Bengal, if such item rates are available therein as stated below:

1. SoR for Building works, Materials and Labour
2. SoR for Sanitary and Plumbing works
3. SoR for Roads & Bridges works
4. SoR for Electrical works

In case any item of work is not covered in any of the above mentioned Schedule of Rates (SoR) of Public Works Department, such items may be considered from the existing Schedule of Rates of the concerned Circle or other Circle offices in the Irrigation & Waterways Directorate, till the time an 'Unified Schedule of Rates' is framed and published in this Department.

This order takes immediate effect.
