NOTIFICATION

In continuation of the exercise of restructuring and reorganization of various offices in the Irrigation & Waterways Directorate to ensure increasing efficiency of the delivery system and more or less even distribution of workload among various Circles and Divisions, it has been decided to take up the following measures:

- (a) Headquarters of Circles and Divisions stated in Column-2 of Table 1.0 of the enclosed Annexure shall be shifted to the locations stated in Column-4 of the said Table.
- (b) Territorial jurisdictions of various Circles and Divisions shall be reoriented as per Table 2.0 of the enclosed Annexure.
- (c) Restructuring of Teesta Design Circle under Teesta Barrage Project shall be made in accordance with Table 3.0 of the enclosed Annexure.
- 2. There will be no fresh creation or permanent abolishment of any post due to reorientation of jurisdictions, other than redesignation of a few of the Divisions and change of treasuries for the Drawing & Disbursing Officer (DDO) due to shifting of headquarters. Necessary permission of the Directorate of Treasuries & Accounts (DTA) and new DDO Codes are being obtained separately.
- 3. In case of transfer of posts from one office to another, the serving incumbent holding the post during transfer shall also join in the new office, unless stated otherwise. Service of number of posts in any particular Circle cadre who get posted to the other Circle due to this reorganization shall be treated as deemed deputation. This would not be adversely affect the seniority or promotion prospect of any Circle staff in any manner. The following terms and conditions are to be maintained in this regard:
 - (a) Existing promotional prospects and seniority of the employees in different cadres under existing Circles shall remain unaltered till the end of their service in the same Circle establishment as before the restructuring.
 - (b) Existing vacant number of such post / posts in the basic grade in the Circle cadres under lending Circle in the category shall not be filled up.
 - (c) Existing vacant number of such basic grade post / posts of all such Circle cadres under lending Circle shall be converted to the equivalent basic grade post / posts in the Circle cadres under borrowing Circle.

- (d) Number of such basic grade post / posts of all such Circle cadres under lending Circle as and when will fall vacant by way of promotion or retirement or otherwise shall forthwith be converted to the equivalent post / posts in the Circle cadres under borrowing Circle.
- 4. This phase of reorganization and restructuring will take effect as follows:
 - (i) Shifting of headquarters for SI.1 of Table 1.0 and SI.1 to 4 of Table 3.0 should be completed by 31st October 2016, so that the new offices are made effective from 1st December 2016. In case of SI.2 to 6 of Table 1.0, prescribed timeline is one and half year from the date of issue of this order or completion of new buildings at the respective premises, whichever is earlier.
 - (b) Reorientation of jurisdictions of different Circles and Divisions should also be made effective from 1st November 2016.
- 5. This issues with the approval of Hon'ble Minister-in-charge of the Department.
