## **MEMORANDUM**

Finance Department has brought out certain amendments in the delegation of financial power of the Engineer officers of various Departments for 'Technical Sanction' and 'Tender Acceptance' vide their Memorandum No.5458-F(Y) dated 27<sup>th</sup> June 2012, No.6427-F(Y) dated 25th July 2012 and No.9754-F(Y) dated 3<sup>rd</sup> December 2012.

These Memorandums and Notifications are available in the website of the Finance Department <u>www.wbfin.nic.in</u>. It is obligatory on the part of all Engineering (Works) Departments to follow those during floating of tenders including e-tenders, and Department specific orders are not always necessary.

However, clarifications have been sought from various quarters in the Irrigation & Waterways Directorate for some time past regarding delegation of financial power to the engineer officers and competency for acceptance of e-tenders, and role of Government Appointed Tender Committee as contained in the Notifications of the Finance Department vis-à-vis this Department.

In view of above, in supersession to this Department Notification No.01-IWB dated, 19.07.2012, the modified order incorporating the amendments considered by the Finance Department in matters relating to delegation of financial powers, (DFP) to the engineer offices is detailed here under below:

2. Delegation of power for accordance technical sanction and acceptance of tenders for all major / minor / maintenance / Deposit Works and Tools & Plants, Furnitures & other items charged under Works Head from Departmental / Non-Departmental budgetary allocations under Plan & Non-Plan.

Note-1: Government appointed Tender Acceptance Committee is to be defined and identified as (DTC) Departmental Tender Committee, (Composition & Function stated below in Para. 3) will normally recommend and approve acceptance of tender by the concerned Chief Engineers of the lowest valid bid out of <u>minimum three valid tenders</u> up to 5% above the Tender value (amount put to tender) for works having tender value in excess of ₹ 4.00 crore, subject to the provisions contained in Para 3.

Above 5% but up to and below 10% of the Tender Value may be accepted by the DTC for peculiar situations and special circumstances, provided budgetary provision and administratively approved cost is not exceeded because of such excesses and the lowest tender out of three valid tenders is accepted. Reasons for doing so shall be kept on record.

Note-2: Provided Administrative Approval / Revised Administrative Approval from the competent authority is received, as and when required under the prescribed rules, and budgetary provisions (administratively approved cost for plan works/expenditure allocation on sanctioned estimates for Non-Plan works in that the FY is not exceeded and the lowest tender out of at least three valid tenders is accepted. In case, administratively approved sanctioned estimated cost is exceeded, and additional fund is required, after acceptance of tenders would have to be referred to the Government in the Irrigation & Waterways Department as per usual procedure for accordance of revised administrative approval and for making provision of additional fund in the budget.

- <u>Note-3</u>: Provided prior approval of Superintending Engineer to the list of work(s), including the work in question is received along with concurrence of Executive Engineer to such sanction of estimate & acceptance of tender is accorded, and also administratively approved sanctioned estimated cost is not exceeded with the lowest valid bid out of minimum three valid tenders is accepted.
- 3. Constitution of Departmental Tender Committee (DTC) in the Irrigation & Waterways Department:

Two Committees are hereby re-constituted, one for North Bengal and the other for South Bengal with the following composition:

3.1 Functions of the Departmental Tender Committee (DTC) and related procedural modalities are detailed in the next page:

a. Concerned Superintending Engineer, for all e-tenders of Tender Values above Rs 4.0 Crore after opening the financial bids of the technically qualified bidders, forward the financial picture of the comparative statement duly test checked by the concerned Divisional Accounts Officer/Accountant to the concerned Chief Engineer with his comments as to whether further bids are necessary to lower down the lowest rate received. The concerned Chief Engineer, thereafter, would take a decision after application of mind on the comment of the Superintending Engineer and attempt to further lower down the rates, if felt necessary, through sealed bids.

Open bid is normally discarded to ensure confidentiality and transparency. However in extraordinary situations, if in the opinion of the Tender Accepting Authority the rate of L1 is still high (being above Tender Value) and there is a scope for lowering, <u>only L1</u> bidder may be requested to attend an open bid for further lowering down the rate on pre-notified time and date in presence of the Tender Accepting Authority.

Finally, comparative statement showing rates finally obtained and other necessary documents as may be required for appraisal of the DTC, would have to be placed by the concerned Chief Engineer.

b. The DTC after having due deliberation would either recommend acceptance of the lowest rate up to 5% above the amount put to tender, in cases where at least <u>three number of valid bidders</u> have participated in financial bids or may advice fresh Tender. There is no need or refer the matter to the Finance Department.

In case the administratively approved estimated sanctioned cost is exceeded, and there is likely requirement of additional fund, the case after acceptance would have to be referred as per usual procedure to the Government in the Irrigation & Waterways Department for accordance of revised administrative approval and making suitable provision of additional fund in the budget.

- c. Variation up to 10% on the plus side may also be accepted by the DTC for peculiar situations and special circumstances only, provided budgetary provision (Administratively approved sanctioned estimated cost) is not exceeded because of such excesses and the lowest tender out of three valid tenders is accepted. Reasons for doing so shall be kept on record. Similar procedure of obtaining revised administrative approval as started at para 3.1(b) above, needs to be followed for these cases as well.
- d. Tenders above this limit of 10 % should not normally be accepted and may be referred to the Government with specific recommendation, if the Committee is of the opinion that there is no scope of lowering down the rate below 10%.
- e The DTC will generally consider all tenders where amount put to tender is above ₹ 4.00 crore. However, tenders where the lowest rate is above 5% for all tenders and the concerned Chief Engineer is of the opinion that there is little scope for lowering down the rates and the work is urgently required to be executed, the same should be placed before the DTC for processing as per modalities stated in Paragraph 3.1.d. above, irrespective of the amount put to tenders.
- f. The lowest tender for all works should be accepted as a rule. If for any reason the lowest tender is not accepted reference to be made to the Finance Department recommended by the DTC through this Department for decision as to which of the contractors the work should be given.
- g. Even if, after taking appropriate steps, in regard to relaxation of the eligibility criteria and other terms & conditions, the response to the Re-Tender is less than three, that tender may be accepted without reference to the Finance Department, provided the rates do not exceed the schedule rates (SoR) beyond 5% in case of works and within the overall administratively approved cost. <u>Otherwise, such cases should be referred to the Finance Department for decision</u> enclosing recommendation by the DTC and filled up copy of 'Tender Register' in the prescribed proforma.

- h. The concerned Superintending Engineer will invite tender notice for all works which are under purview of acceptance of either himself or by his Chief Engineer.
- i. Tender Committees already constituted for deciding on issuance of e-tender papers will continue to function as well.
- j. Quorum of the DTC for North Bengal is deemed to have been achieved only if all the members remain present. However, in order to form quorum of the DTC for South Bengal, presence of the concerned Chief Engineer, concerned Superintending Engineer, concerned Executive Engineer and two other Chief Engineers would suffice. Senior most Chief Engineer attending the DTC meeting would function as the Chairman.
- k. The DTC meetings may be utilised for obtaining recommendations for acceptance of tender for works under the jurisdiction of more than one Chief Engineer provided all concerned remains present.
- 4. This order will have immediate effect and moreover tenders which have not yet been accepted formally also would come in the purview of this order.

The Departmental Code would be amended accordingly is due course.
