**NOTIFICATION**

In continuation of the exercise of restructuring and reorganization of various offices in the Irrigation & Waterways (I&W) Directorate as well as in the Secretariat Office in the I&W Department to optimize limited manpower resources through re-deployment, the Governor is pleased, in the interest of Public Service, to restructure the following offices and also to set up new offices as stated below.

**Restructuring in the Secretariat Office in the I&W Department**

2. 1 post of Superintending Engineer (Civil), 2 posts of Executive Engineer (Civil) and 3 posts of Assistant Engineer (Civil) have been transferred to the Secretariat Office in the I&W Department and converted to corresponding equivalent posts, i.e. Joint Secretary, Deputy Secretary and Assistant Secretary respectively without any additional financial involvement, on receipt of in-principle no objection from P&AR Department, subject to concurrence of the Finance Department. Modalities of filling up these posts by technical officers, borne from the West Bengal Engineering Service in the I&W Department, are being finalized in consultation with the P&AR Department. Details of redesignation and transfer of existing posts in the I&W Directorate may be seen in the Annex-5 (Sheet-1/1 Sl.3), Annex-6 (Sheet-1/2, Sl.7 & Sheet-2/2, Sl.22) and Annex-8 (Sheet-10/23 & Sheet-14/23) of this Notification.

**Restructuring of the Office of the Chief Engineers**

3. Offices of the all 5 (Five) outstationed Chief Engineers, i.e. Chief Engineer (Teesta Barrage Project) (TBP) at Siliguri, Chief Engineer (North East) at Jalpaiguri, Chief Engineer (North) at Malda, Chief Engineer (West) at Purba Bardhaman and Chief Engineer (South West) at Paschim Medinipur, have been restructured and strengthened so as to enable the Chief Engineers to exercise independent function in regarding to matters related to establishment of staff under their control and also related to sanctioning of project reports, estimates and acceptance of tenders in accordance with delegation of power. Details of regular staff strength of these Chief Engineers have been shown in Annex-1 (6 Sheets). Henceforth, office of Chief Engineers at Jalasampad Bhaban will be redesignated as office of the Chief Engineer (South), Chief Engineer (Design & Research) (D&R) and Director of Personnel (DP) & Ex-officio Chief Engineer, and this office will perform official works of only these three Chief Engineers posted at headquarters. Offices of Chief Engineer (TBP) and Chief Engineer (North) will be manned by Regional Clerical Cadre (Non-PSC) and other Regional Cadre staff identified and

transferred from local subordinate offices, in parity with the office of Chief Engineer (North East). PSC recruited Directorate Level Clerical Cadre (from Administrative Officer upto Lower Division Assistant) will be utilized for manning in the office of the Chief Engineer (West), office of the Chief Engineer (South West), common office of the Chief Engineer (South), Chief Engineer (D&R) and DP & Ex-officio Chief Engineer and also in the State Project Management Unit (SPMU) and two District Project Management Units (DPMUs) being set up for implementation of externally aided West Bengal Major Irrigation and Flood Management Project (WBMIFMP). Norms to be followed during transfer of the abovesaid PSC recruited Directorate Level Clerical Cadre to different offices have been detailed at Annex-2 (Sheet-1/2 to Sheet-2/2). Functions assigned to the five outstationed Chief Engineers have further been delineated at Annex-3 (Sheet-1/2 to Sheet-2/2). Summary statement of sanctioned strength of the Directorate Level Clerical Cadre at various offices after restructuring has been presented in Annex-4 (Sheet-1/1). In order to follow the norms of transfer, all posts including incumbents of the Directorate Cadre, save and except two incumbents, 1 (One) Upper Division Assistant and 1 (One) Lower Division Assistant, both serving in the office of Chief Engineer (TBP) as local staff, will initially be brought back to the common office of Chief Engineer (South), Chief Engineer (D&R) and DP & Ex-officio Chief Engineer, and transfer to other offices will be made as stated hereinabove, as per the prescribed norms. Henceforth, Superintending Engineers attached to Chief Engineers designated as "Superintending Engineer & Personal Assistant" will be redesignated as "Superintending Engineer attached to Chief Engineers".

#### **Restructuring of the Offices of the Subarnarekha Barrage Project**

4. There is practically little progress in commencing the work of Subarnarekha Barrage Project due to various constraints including land acquisition and forest clearance. Keeping in consideration the continuation of such a situation in near future, it has been decided to utilize the manpower of this project, presently lying almost idle, in other places as explained below:
  - (i) Subarnarekha Canal Circle is redesignated as Kangsabati Canal Circle-II, without change of headquarters to exercise control of three Divisions in Paschim Medinipur and Jhargram, i.e. Kangsabati Canal Division – I, IV & V. Original Kangsabati Circle, with headquarters at Bankura, will be redesignated as Kangsabati Canal Circle-I with three Divisions, i.e. Kangsabati Canal Division – II & III and Bankura Irrigation Division, thereunder.
  - (ii) Subarnarekha Barrage Circle is redesignated as Western Circle-III, with headquarters at Tamruk, District Purba Medinipur, with East Midnapore Division and Contai Irrigation Division thereunder.
  - (iii) Subarnarekha Head Quarter Division is redesignated as Jhargram Flood Management & Planning Division, with headquarters at the newly opened District

Jhargram, to look after all works relating to flood management, existing as well as new medium and minor irrigation schemes within Jhargram District. Jhargram Irrigation Subdivision, now under the control of West Midnapore Division will be transferred under the control of new Jhargram Flood Management & Planning Division, with its jurisdiction and manpower.

- (iv) Subarnarekha Barrage Division is disbanded and its staff strength is transferred to other offices.
- (v) Existing Western Circle-II, with headquarters at Midnapore will now have three Divisions, i.e. West Midnapore Division, KKB Project Division and the newly opened Jhargram Flood Management & Planning Division.

Details of restructuring of posts and incumbents of various offices under Subarnarekha Barrage Project may be perused at Annex-7 (Sheet-1/14 to Sheet-14/14).

#### **Restructuring of the Offices of the Teesta Barrage Project**

5. Rightsizing of various offices of Teesta Barrage Project have been made befitting and commensurate with the present as well as near future workload and surplus manpower has been utilized in other offices under the I&W Directorate. Following offices under this project are disbanded:
  - (i) Teesta Canal Circle at Raiganj with Teesta Canal Head Quarter Division and Teesta Canal Division-III, thereunder.
  - (ii) Teesta Design Circle at Siliguri.
  - (iii) Teesta Canal Investigation Division (including the attached post of Superintending Engineer, Teesta Dam, Canal Project & Investigation Circle) and Teesta Dam Investigation & Design Division, both at Assam More, Jalpaiguri.
  - (iv) Resources Circle at Siliguri with Teesta Resources Division-I and Teesta Resources Division-II thereunder.

Details of reorganization of these offices and transfer of posts to other offices, including list of designated offices taking charge over jurisdictions, official documents, registers, files, papers and other movable and immovable assets, have been shown in Annex-8 (Sheet-1/23 to Sheet-23/23).

#### **Opening of a new Offices at Asansol, headquarter of the District Paschim Bardhaman**

6. North Bengal Planning Division at Malda is redesignated as Asansol Irrigation Division and transferred to Asansol, District Paschim Bardhaman. Details of transfer of posts, manning and jurisdiction of Asansol Irrigation Division have been stated at Annex-9 (Sheet-1/4 to Sheet-4/4).

**Opening of new Offices for implementation of the externally aided  
“West Bengal Major Irrigation and Flood Management Project”  
(WBMIFMP)**

7. A State Project Management Unit (SPMU) at Jalasampad Bhaban, Bidhannagar and two District Project Management Units (DPMUs), one at Kanainatsal, Burdwan Town, District Purba Bardhaman and the other at Nazirganj, District Howrah are newly established, co-terminus with the implementation of WBMIFMP, as referred above. The SPMU and DPMUs will have various categories of posts, mostly made available by transferring posts from the offices of Teesta Barrage Project, and also from other offices on a few occasion, except the following posts, which are to be created anew by keeping corresponding feeder posts, in the I&W Directorate as vacant with due concurrence of the Finance Department, subject to approval of the Cabinet.

(i) Project Director in the rank of Chief Engineer	...	1 No.
(ii) Additional Project Director in the rank of Superintending Engineer	...	2 Nos.
(iii) Office Manager in the rank of Administrative Officer	...	1 No.

Further two posts in the SPMU are to be manned by the officers borne in the cadre of WB Audit & Accounts Service, from the Finance Department on deputation basis. Creation and filling up of all the six posts stated above will take place after approval of the Cabinet. Detailed staffing pattern in the SPMU and DPMUs have been shown in Annex-10 (Sheet-1/4 to Sheet-4/4). Restructuring and strengthening of four irrigation Divisions of the I&W Directorate, i.e. Howrah Irrigation Division, Hooghly Irrigation Division, Burdwan Irrigation Division and Right Bank Irrigation Division, designated as dedicated District Project Implementation Unit (DPIU), in the five districts of Howrah, Hooghly, Purba & Paschim Bardhaman and Bankura respectively have also been done as detailed at Annex-11 (Sheet-1/8 to Sheet-8/8).

**Posting of additional Executive Engineers as  
Executive Engineer-II in five working Divisions**

8. In order to cope up with the increasing workload due to vast territorial jurisdiction, additional Executive Engineers as Executive Engineer-II are posted at Lower Damodar Construction Division, Damodar Canals Division, Lower Damodar Irrigation Division, Joynagar Irrigation Division and Canals Division. Modalities of posting, functioning and exercising of powers of Executive Engineer-I vis-à-vis Executive Engineer-II in these Divisions have been delineated at Annex-12 (Sheet-1/3 to Sheet-3/3).

**General considerations, procedural formalities and treasury functioning**

9. Summary statement of reorganization of Superintending and Executive Engineers has been shown in Annex-5 (Sheet-1/1) and Annex-6 (Sheet-1/2 & Sheet-2/2). Exhaustive list of offices being disbanded or transferred as new offices at places beyond the jurisdiction of existing linked treasuries and thus requiring surrendering of DDO Codes, has been detailed at Annex-13 (Sheet-1/5 & Sheet-2/5). Similarly, list of offices being created anew

or renamed and transferred from other places with additional strengthening and requiring new / additional DDO Codes, has also been detailed at Annex-13 (Sheet-3/5 to Sheet-5/5).

10. It is of utmost importance to follow procedural formalities, particularly related to treasury functioning, during implementation of the entire process of restructuring for proper upkeep of old records, documents, registers and to avoid glitches in timely disbursement of salaries and wages of government / contractual staff during the transition phase of shifting. While DDO Codes for new offices are being obtained centrally from the Director of Treasuries & Accounts, by the I&W Department, all concerned, particularly Heads of Offices and DDOs are advised to carefully read and follow the directions issued in the 'Remarks' or 'Notes' of the Annexes of this Order, especially at Annex-14 in entirety (Sheet-1/9 to Sheet-9/9).
11. Several posts in Circle Cadre, lying vacant for long time, are either not required, or cannot be filled up due to various reasons. List of such posts have been shown in Annex-15 (Sheet-1/1). These vacant posts are hereby surrendered. In a like manner, surplus posts of Sr. Accounts Clerk of AGWB lying vacant for long time and post of Divisional Accounts Officer becoming surplus due to disbandment of offices after restructuring have been shown in Annex-16 (Sheet-1/1). AGWB is being moved separately to place Divisional Accounts Officers at other offices under the I&W Directorate for filling up vacancies.
12. Superintending Engineers of various Circles, receiving posts of Circle Cadre staff from other Circles, will prepare a fresh gradation list of Circle Cadre staff under their control by considering both the existing staff as well as new staff joining the Circle, due to transfer of posts from other Circles. Inter-se-seniority of such Circle Cadre staff will be determined in the basis of date of joining of incumbents in the Irrigation & Waterways Circles, either in their Circles (or Divisions thereunder) or in other Circles (or Divisions thereunder), from which the posts are transferred. While calculating the sanctioned strength of such staff in any Circle, posts surrendered as detailed in Annex-15 (Sheet-1/1) are to be considered. Superintending Engineers attached to various outstationed Chief Engineers will prepare and maintain similar gradation list for all the Circle Cadre posts, transferred to the office of Chief Engineer.
13. Offices opened or shifted to new locations in various districts will be accommodated initially either within Departmental buildings or in rented premises. However, District Project Management Unit (DPMU) for Howrah District will temporarily accommodated in Ground Floor / 10th Floor of Jalasampad Bhaban, till alternate arrangement for shifting the office at Nazirganj, District Howrah could be made. Construction of new office buildings may be taken up in due course, if required. Keeping in consideration the paucity of support / menial staff in the new or newly shifted offices, Heads of these offices are hereby authorized to outsource the works related to guarding and housekeeping of the office buildings, following usual tender formalities. Expenditure for running of the offices

may be incurred in accordance with Delegation of Power Rules 1977, amended vide Finance Department No.4411-F(Y) dated 04.06.2015. Necessary funds for incurring expenditure in connection with the offices will be provided on demand. Heads of the newly opened offices are to approach the Department for getting new landline telephone connections, if required.

14. Considering the urgent need of placement of clerical cadre at regional level in various offices under restructuring, DP & Ex-officio Chief Engineer is directed to bring about promotion orders for Head Clerks and Upper Division Clerks, on the basis of a suitable cut-off-date as may be deemed fit, positively by 31<sup>st</sup> August, 2017.

### Implementation Phases

15. Restructuring including disbandment and setting up of the following offices, considered under Phase-I, will take place by 18<sup>th</sup> September 2017.
- (a) Office of the outstationed Chief Engineers, subject to the conditions that;
- (i) Promotion orders to fill up the vacant posts of Head Clerk and Upper Division Clerk (both regional cadre) in the offices of Chief Engineer (TBP) and Chief Engineer (North) are issued by the DP & Ex-officio Chief Engineer and incumbents' physical join in these offices, before transfer of PSC recruited Directorate Cadre Clerical staff from these offices.
  - (ii) Posting of personnel as per norms prescribed in Annex-2 (Sheet-1/2 to Sheet-2/2) is made simultaneously with the release of such staff from the office of Chief Engineer (West) and Chief Engineer (South West).
- (b) Offices newly opened for the SPMU (at 9th Floor of Jalasampad Bhaban), DPMU for Burdwan District and DPMU for Howrah District, subject to the condition that posts of the Project Director (in the rank of Chief Engineer) and 2 Additional Project Directors (in the rank of Superintending Engineer) will be manned by existing officers of equivalent rank on dual charge (one main and one additional), till Cabinet approval towards creation and filling up of such posts are obtained. Manning in posts of Additional & Deputy Project Directors on similar dual charge may also be made for the DPMUs till new incumbents join in these offices.
- (c) Subarnarekha Canal Circle, since renamed as Kangsabati Circle-II, and part of Subarnarekha Barrage Division and Subarnarekha Head Quarter Division, to the extent related to strengthening and renaming Subarnarekha Canal Circle.
- (d) Placement of Executive Engineer-II in Damodar Canals Division, Lower Damodar Irrigation Division, Joynagar Irrigation Division and Canals Division.
- (e) Disbandment of following offices / posts under Teesta Barrage Project:

- (i) Teesta Canal Investigation Division along with the attached Superintending Engineer, Teesta Dam Canal & Project Investigation Circle
  - (ii) Teesta Dam Investigation & Design Division
  - (iii) Teesta Design Circle
  - (iv) Teesta Resources Division-II
  - (v) Liaison Officer attached to Resources Circle.
16. Restructuring and setting up of the remaining offices considered under Phase-II, will take place by 16<sup>th</sup> October 2017, except inter-Division transfer of irrigation Subdivisions relating to Howrah Irrigation Division, Lower Damodar Construction Division, Hooghly Irrigation Division, Damodar Canals Division, Burdwan Irrigation Division, Right Bank Irrigation Division and Kangsabati Canal Division-III, which will take place by between 16<sup>th</sup> November to 16<sup>th</sup> December 2017. The four Divisions designated as District Project Implementation Units, i.e. Howrah Irrigation Division, Hooghly Irrigation Division, Burdwan Irrigation Division and Right Bank Irrigation Division will carry out works related to WBMIFMP, in addition to their own duties till 15<sup>th</sup> November 2017. Charges of normal routine works will be relinquished by these Divisions along with transfer of jurisdiction, in favour of the designated Divisions in between 16<sup>th</sup> November to 16<sup>th</sup> December 2017, after which these four Divisions will exclusively be engaged in project works.
17. Creation of new posts has been concurred to by the Finance Department, vide their U.O. No.Group-P2/2017-2018/0149 dated 23.05.2017.
18. This issues with the approval of Hon'ble Minister-in-charge of this Department.

General Note : All the outstationed Chief Engineers are hereby authorized to issue transfer order to staff belonging to Regional Cadre in their offices and all other subordinate offices within their jurisdiction under intimation to the Director of Personnel & Ex-Officio Chief Engineer, except Circle Cadre staff for whom the concern Superintending Engineers would be the transferring authorities for intra-Circle transfer. **3. Norms of Transfer / Posting**

- (i) All employees are deemed to be at office of the Chief Engineer (South), Chief Engineer (D&R) and Director of Personnel & Ex-officio Chief Engineer, Irrigation & Waterways Directorate.
- (ii) Initial posting will be on the basis of option from all the Head Assistants, Upper Division Assistants and Lower Division Assistants for the offices having ID Number “A”, “B” & “C”. If the number of option for a particular office for a particular cadre exceeds the number of post / vacancy in that office, preference will be given to the senior employees as per gradation list.

The rest of the vacancies will be filled up from the junior employees of Head Assistant / Upper Division Assistant / Lower Division Assistant in ascending order of seniority as per gradation list. The junior most employees will be posted at the furthest point, i.e. at “A” and next senior would be posted at “B” and “C” respectively. Posting at the two offices under ID “HQ” will be made from the remaining staff after filling up the posts of “A”, “B” and “C”. In case of simultaneous posting of personnel of any particular category in the two offices under ID “B”, senior most will be posted at the office of the Chief Engineer and junior most will be posted at the DPMU-I of WBMIFMP headed by the Superintending Engineer.

- (iii) After completion of a specific tenure in a particular office having IDs "A", "B" and "C" employees will return to "HQ" and vacancy will be filled up by the employees from "HQ" for all categories. Subsequent vacancies will be filled up in the same manner as stated in Sl.(ii), i.e. firstly by option from the employees and then from the junior employees. Tenure of staff at "HQ" offices would continue till an employee posted in the "HQ" offices comes under the purview of posting to other offices (i.e. "A", "B" and "C") as per the gradation list.
- (iv) All categories of employees above will have tenure of 2 (Two) years from the date of release in a particular office where they are posted. If any employee posted in the offices having ID "A" / "B" / "C" opts for extension to stay in that office, beyond the stipulated tenure, for a further term or multiple thereof, his/her prayer may be considered.
- (v) Junior employees will be posted from ID "A" to "C" in the order of distance if vacancy arises in more than one office at the same time.
- (vi) Employees who are presently and physically posted outside "HQ" or who are presently posted at "HQ" on deployment, after completion of his/her physical posting outside "HQ", will not be considered for posting at the first instance in all the offices (under ID "A", "B" and "C"). Exception may be made if situation so demands.
- (vii) If any employee refuses to accept promotion on the ground of his/her posting in a particular office, he/she will be considered for further promotion only after expiry of 1 (One) year.
- (viii) Employees who will retire within 1 (One) year from the due date of movement / transfer in question he/she will be exempted. If any employee, who is already posted outside "HQ" is due to retire on superannuation within 1 (One) year, he/she will return to the "HQ", if not otherwise applied for.
- (ix) The name of employees as per gradation list will be considered for a particular vacancy, in a particular office with reference to the date of occurrence of such vacancy, irrespective of date of issuance of transfer order for filling up of such vacancy.
- (x) If any employee posted at any of the offices other than "HQ" gets promotion before completion of the specified tenure and is directed / allowed to continue in that office after promotion, period of stay in both the post will be counted to ascertain the continuous tenure after which he/she would be eligible for transfer. In case he/she cannot be accommodated in that office, he/she will be posted at other offices preferably according to descending alphabetical order against vacancy available at the material point of time.
- (xi) The employees who will be posted in the offices having ID "A" / "B" / "C", will be considered for the purpose of further transfer in the respective category to which they belong, only after completion of one full cycle as per gradation list.

### **Functions assigned to outstationed Chief Engineers**

(i) **D.D.O. Functioning**

Presently DDO functioning for the offices of Chief Engineer (Teesta Barrage Project) (TBP) and Chief Engineer (South West) is being done by the Executive Engineer & TA to the Chief Engineer. DDO functioning for the office of Chief Engineer (North East) is being done by the Executive Engineer & TA to Superintending Engineer, North East Irrigation Circle-I. Executive Engineers functioning as Technical Assistants posted at the offices of Chief Engineer (North) and Chief Engineer (West) will also do DDO functioning, after receipt of DDO Codes from the Directorate of Treasuries.

(ii) **WBHS 2008**

All the five outstationed Chief Engineers, i.e. Chief Engineer (TBP), Chief Engineers (North East), Chief Engineer (North), Chief Engineer (West) and Chief Engineer (South West) are hereby empowered to sanction medical bills/claims upto ₹ 1.00 lakh at par with the power enjoyed by the Director of Personnel & Ex-officio Chief Engineer related to WBHS 2008 for the officers and staff under their control. Cases involving claims beyond this limit may directly be referred by the Chief Engineers to the Department.

(iii) **GPF**

All these outstationed Chief Engineers are further authorised to sanction the amount of withdrawal from GPF of the Superintending Engineers under their control and their attached Superintending Engineers are authorised to sanction such amount of withdrawal of GPF for other staff of the office of the Chief Engineer. GPF Account of Group-D staff posted in the office of the Chief Engineers may be maintained by the Executive Engineer & TA to those Chief Engineers, or other officials functioning as DDO. Any correspondences in respect of GPF, if necessary, are to be made by the office of the Chief Engineers directly to the Department and to the Accountant General (A&E), WB through the Department.

(iv) **Service Books & Sanction of Leave**

Service Books of the employees of the office of the Chief Engineers and also of the Superintending Engineers under the control of Chief Engineers are to be maintained and updated at the office of the Chief Engineers. Such Chief Engineers are empowered to allow increment of employees under their control. All sorts of leave of these officers and staff are to be granted by the concerned Chief Engineers. Superintending Engineers attached to the Chief Engineers will be the Cadre Controlling Authority in respect of Circle Cadre post at the office of the Chief Engineers and those officers will also function as Superintending Engineers of deemed Circles, in respect of such Circle Cadre staff.

(v) **Pension**

Chief Engineers will also be allowed to function as Pension Sanctioning Authorities (PSAs), being Heads of the offices and pension cases of all the employees of their offices may be dealt by the offices, without referring to Director of Personnel & Ex-officio Chief Engineer.

**(vi) Permission**

Necessary permission for purchase of commodities, houses, flats, house building loans, etc. in respect of employees and officers under the control of these Chief Engineers will be accorded by them. If necessary, they may forward the cases direct to the Department, without referring to Director of Personnel & Ex-officio Chief Engineer.

**(vii) Transfer & Posting**

These outstationed Chief Engineers are authorised to issue transfer orders of staff belonging to Regional Cadre in their offices or any other offices under their jurisdiction, under intimation to Director of Personnel & Ex-officio Chief Engineer, excepting intra-Circle transfer of Circle Cadre staff who are under the control of Superintending Engineer. However, promotion order for such staff and posting on promotion or new appointment would be continued to be issued by the Director of Personnel & Ex-officio Chief Engineer. While issuing order for such posting on promotion or on new appointment, the Director of Personnel & Ex-officio Chief Engineer should take into consideration the views / suggestions / requests of all the Chief Engineers. Director of Personnel & Ex-officio Chief Engineer would also be the authority to issue transfer order in cases when an employee, either on the basis of his prayer or due to other jurisdiction of another Chief Engineer. All the Chief Engineers including the outstationed Chief Engineers are also authorised to issue inter-Circle transfer orders of Circle Cadre staff within their respective jurisdictions.

**(viii) Sanctioning of estimates and acceptance of tenders**

The outstationed Chief Engineers will utilize the technical officers, attached to them, from Superintending Engineers to Junior Engineers for sanctioning of estimates and acceptance of tenders, in accordance with delegation of power.

**E. New offices set up in connection with implementation of West Bengal Major Irrigation and Flood Management Project (WBMIFMP)**

- E.1 Reference to creation of posts and modes of filling up the posts for 3 new offices in connection with implementation of WBMIFMP, i.e. one State Project Management Unit (SPMU) at Jalasampad Bhaban, Bidhannagar and two District Project Management Units (DPMUs), one each at Burdwan, District Purba Bardhaman and the other presently at Jalasampad Bhaban, to be subsequently shifted to Nazirganj, District Howrah, may be seen at Annex-10 (Sheet 1/4 to 4/4). List of designated DDOs for these offices may further be seen at Annex-13 (Sheet-2/15, Sl.6 & 7 and Sheet-3/15, Sl.8).
- E.2 Drawing & Disbursing Officers (DDOs) of each of the offices stated under Categories B, C, D & E (i.e. other than those under Category-A which are disbanded) will make out a list of category-wise detailed list of sanctioned posts in these offices, on the basis of transfers / surrendering of posts prescribed at Annexes 1 to 12, which should be considered as permanent staff strength of these offices until further order. The list is to be duly certified by the Head of the Office.

- E.3 All the offices will ensure that transfer of incumbents takes place in accordance with phases of restructuring and within the prescribed time limits prescribed in this order and in subsequent orders to be issued in this regard. DDOs will ensure that Last Pay Certificates (LPCs) are issued promptly so as to enable the employees to join in the new places of posting.
- E.4 Heads of the offices which are being disbanded or transferred to other places involving change of Treasuries, will untag the employees in the HRMS, using their User IDs and Passwords, immediately after transfer of such employees. Such untagging of employees should preferably be done at the 1<sup>st</sup> week of the month, in which the offices are scheduled to be disbanded / transferred
- E.5 Transfer of files, papers, registers and relevant documents, other movable and immovable assets to the designated offices will also be carried out simultaneously.
- E.6 For transferring of Accounts of “Work Deposit”, “Security Deposit” and “Miscellaneous Deposit” lying and maintained in the Treasuries, the DDOs of the Divisions being disbanded or transferred, will draw the challans from the Treasuries under their existing operating Codes, in T.R. Form No.70B, so as to make the balances in these accounts as ‘NIL’. In case, the designated DDOs taking over such accounts function in the same Treasury, DDOs originally holding the accounts will request the Treasury Officers to transfer the balance of deposit accounts in favour of designated DDOs taking over such accounts, by transfer credit or issuance of cheque by the Treasury Officers in favour of the designated DDOs, as the case may be. In case, designated DDOs are linked with separate treasuries, such transfer will be done by issuance of cheque only, for which necessary approval of Finance (Audit) Department, Group-T is being obtained. The designated DDOs receiving such balances by cheque, will deposit the same in their respective banks linked with treasuries in Form TR-7, under the deposit heads of account already being maintained by them.
- E.7 After completion of the process of untagging of employees (stated in Para-4), transfer of files, papers, documents, registers, etc. (stated in Para-5) and transfer of deposit accounts (stated in Para-6), DDOs of the offices being disbanded / transferred to the jurisdiction of other treasuries, will request the respective treasuries to provide certificate for deactivation of DDO Codes, which may be handed over to the new designated DDOs taking over the charge of the papers, documents, registers of the offices being disbanded / transferred. It may be stated here that the DDOs, after deactivation of DDO Codes, may get another 15 days transition time, subject to approval of the Finance (Audit) Department, Group-T, for completing treasury transactions, left during deactivation, if any.
- E.8 Secretariat Office of this Department will intimate Codes of DDOs pertaining to the new offices (i.e. State Project Management Units and 2 District Project Management Units of WBMIFMP) as well as to the offices transferred from jurisdiction of one treasury to another.
- E.9 In the 2nd step, the Secretariat Office of this Department will identify Heads of the above stated new offices and will provide User IDs and Passwords to these Heads of the Offices, for operation of HRMS.
- E.10 As a parallel process, the DDOs joined in the new offices will approach the concerned linked treasuries to provide the following:
- i) User ID & Password for operating the IFMS

- ii) Operating Codes for Accounts relating to
  - (a) Work Deposit
  - (b) Security Deposit
  - (c) Miscellaneous Deposit

In cases, the new DDOs do not belong to new Divisions (i.e. belonging to the office of Chief Engineers or Circles), request will be made for Sl.(i) only.

- E.11 The DDOs of the new offices will then enlist all the personnel joining the offices in HRMS, and will add the Heads of the Offices in that system thereafter. Finally, the Head of the Offices will tag all the employees of the offices in the HRMS, using the User IDs and Passwords already provided by the Department.
- E.12 DDOs of the offices, transferred from the jurisdiction of one treasury to another, with continue to operate their old Codes, even after physical shifting of offices to new locations, till receipt and activation of new DDO Codes.
- E.13 In case of change of name of an office, without involving change of headquarters, Head of the Office / DDO will intimate the name of such office to all concerned, including the Treasury Officer, by issuing an order. Similar procedure will have to be followed for offices involving change of headquarters from jurisdiction of one Treasury to another, with or without change of name.
