## **MEMORANDUM**

Re: Evaluation of bids of the short notice tenders/spot bids for implementation of emergent flood damage restoration work during monsoon.

Reconstitution of Tender Evaluation Committees (TEC) and the High Value Tender Evaluation Committees (HTEC) for Bid Evaluation in the technical evaluation stage of a e-tender have been communicated vide this Department's Memorandum No. 11-W/2017-18 dated 01.08.2017.

In the meantime, due to severe damages inflicted in the recent floods, and the immediate need to take up restoration of embankments and other vital installations damaged in various districts, it has become necessary to lessen the involvement of field level engineer officers in the scrutiny and evaluation process of tender papers/ bid documents.

Considering all aspects, and as a special case in order to restore normalcy after flood related devastation, it has been decided in the interest of public services, that during or immediate aftermath of a severe flood or flood like situation, for undertaking emergent restoration works upto tender value of Rs. 45.00 lakh (normal accepting power of Assistant Engineer is upto Rs. 3.00 lakh and Rs. 45.00 lakh for Executive Engineers) may be tendered with the responsibility of Technical Bid Evaluation assigned solely to the Tender Accepting Authorities or the TEC, if decided by the concerned Chief Engineer of Irrigation & Waterways Directorate.

Chief Engineer concerned may issue a general written instruction to his subordinates during or in the immediate aftermath of such emergency period. Relaxation from conducting TEC/HTEC meeting is also applicable automatically for spot bids, whenever taken up with approval/post-facto approval of Irrigation & Waterways Department and concurrence of Finance Department or in terms of delegated power G.O bearing No. 19-W/2016-17 dated 19.07.2016 communicated vide this Department Memo No. 91-IB dated 19.07.2016.
