The undersigned is directed to state that 1st instalment of allocation for pre-monsoon maintenance & other emergent works for the next financial year of 2019-20 for the Division offices who have already submitted their 'Annual Maintenance Plan' would be equal to the pre-monsoon allocation provided for the current financial year of 2018-19 communicated vide No. 616(7)-IB dated 26.02.2018.

- 2. It may be stated that no such allocation for the next financial year of 2019-20 will be made by this Department to the defaulter offices who are yet to submit the respective 'Annual Maintenance Plan'.
- 3. Concerned Executive Engineers may be directed to complete the procedural paraphernalia, i.e. preparation of estimates, invitation and finalisation of tenders and issue of work orders on urgent basis, by February 2019, so that works having estimated cost upto the prescribed ceiling limits can be commenced and completed before monsoon 2019.
