MEMORANDUM

The Irrigation & Waterways Department is participating in World Bank funded project, namely DRIP (Dam Rehabilitation & Improvement Project)(Phase-II & Phase-III) taking concurrence from the State Finance Department, conveyed vide their U.O. No.-0640 dated 03.07.2019 for rehabilitation of primarily selected 16 structures at a cost of Rs. 345.00 Crore in six years starting from 2020-21.

- 2. As preparatory activity, A Dam Safety Review Panel (DSRP) has been constituted by the Irrigation & Waterways Department, Government of West Bengal vide this Department's Memorandum No-180-I/I-4M-08/2016(Pt-II) dated 27.05.2019 to examine each dam rehabilitation proposal, prepared by the SPMU/DRIP for implementation under DRIP. Except Chief Engineer (South-West) of Irrigation & Waterways Directorate, all the members of the DSRP are either retired Central Government Employees or presently employed at NHPC Ltd (National Hydro Power Corporation Limited) or IIT (Indian Institute of Technology), having their residences or office outside the State.
- 3. The DSRP members have already started their activity by undertaking site visits at the dam and barrage locations in the State for preparing the DSRP report for submission to Central Water Commission, Government of India which is a prerequisite for funding of any Dam Rehabilitation proposal under DRIP. The modalities of bearing the expenditures towards transportation, boarding and lodging of the DSRP members during their visit in connection with DRIP, was referred to the State Finance Department to obtain their concurrence.
- 4. In the context of above, the undersigned is directed to inform that the State Finance Department has agreed to bear all the charges of the DSRP members, during their journey days (Journey days include one day before and one day after the block period of visit) in connection with DRIP, towards air/train and other transportation charges, lodging and boarding as per extant norms of the State Government. The approval of the State Finance Department has been accorded in e-file no-IW-14014(16)/1/2019-Section (IW) on 18.10.2019
