NOTIFICATION

- 1. In pursuance of the Memo No. A-126-PSC (A) dated 21st December, 2021 of the PSC, West Bengal, the Governor is pleased to appoint Shri Subhankar Mukherjee as Assistant Engineer (Civil) under the Irrigation & Waterways Department, on temporary basis against a regular post of Assistant Engineer (Civil), borne in the cadre of the West Bengal Engineering Service (Irrigation) under Irrigation & Waterways Department in the Level 16 of Pay Range between Rs. 56100/--Rs.144300/- under the Pay Matrix of WBS(ROPA) Rules, 2019, plus D.A. and other allowances as admissible under the general orders of Government in force from time to time, with effect from the date on which he will actually join in the new assignment and post him as Assistant Engineer (Civil) [Additional] in the Right Bank Irrigation Sub Division under Right Bank Irrigation Division, Irrigation & Waterways Directorate against a vacant post, until further order.
- 2. Shri Subhankar Mukherjee has been temporarily appointed as Apprentice JE/P.Way in the Office of the Divisional Railway Manager, Alipurduar Junction under the North East Frontier Railway by the Indian Railways on 21/09/2020 (F.N), by submitting a bond to the concerned authority according to the terms and condition, as laid down in clause 1410 (i) CHAPTER XIV of Indian Railway Establishment Act that Shri Mukherjee will be liable to serve the Indian Railways for a minimum period of 05 (Five) years or he will be liable to refund the whole cost of training period as well as any other money paid to him during this period.
- 3. Further, as per existing norms of Indian Railways, the expense may be exempted from refunding the cost of training in the event of selection to other post in the public sector under administrative control of the Central or State Government, if Shri Mukherjee will submit a fresh bond to the new employer that he will serve them the balance of the original bond period.

- 4. Accordingly, Shri Subhankar Mukherjee is appointed to the post of Assistant Engineer (Civil) under Irrigation & Waterways Department subject to the condition that he will serve this Department till dated 21/09/2025 (F.N) and in case, Shri Subhankar Mukherjee fails to serve this Department or leaves before completion of the stipulated period, for a job, where an exemption from bond obligation is not available, the proportionate money or any amount of money as demanded by the Railway Administration shall be paid by him.
- 5. In the event of any further selection in favour of Shri Mukherjee to any other post in the public sector under administrative control of the Central or State Government, the condition, as stated in para -3 above, shall remain unchanged.

This order issues in the interest of public service and will take immediate effect.

- b) To ask the candidate to make a declaration of his date of birth in proper form and submit the same together with attested copies of his/her certificate of School Final/Higher Secondary or equivalent examination (one copy each of these documents) direct to Irrigation & Waterways Department and also to the Director of Personnel & Ex-officio Chief Engineer, I&W Dte. positively on his/her joining as Assistant Engineer (Civil).
- c) The oath of allegiance should be administered to the candidate on his joining as Assistant Engineer (Civil) in proper form by concerned Executive Engineer and to report to this effect should be submitted to Irrigation & Waterways Department as well as the Director of Personnel & Ex-officio Chief Engineer, I&W Dte.

- e) The newly appointed Assistant Engineer should be given training for one month about the activities and procedure of the works of Irrigation & Waterways Department before taking over the charges of Sub-Division.
