 Directorate.
- b. To ask the candidate to make a declaration of his/her date of birth in proper form and submit the same together with attested copies of his/her certificate of School Final/Higher Secondary or equivalent examination (one copy each of these documents) direct to Irrigation & Waterways Department and also to the Director of Personnel & Ex-officio Chief Engineer, I&W Dte. positively on his/her joining as Assistant Engineer (Civil).
- c. The oath of allegiance should be administered to the candidate on his/her joining as Assistant Engineer (Civil) in proper form by concerned Executive Engineer and to report to this effect should be submitted to Irrigation & Waterways Department as well as the Director of Personnel & Ex-officio Chief Engineer, I&W Dte.
- d. The date on which the candidate joins his/ her post should be intimated to this Department in time.

- e. The newly appointed Assistant Engineer should be given training for one month about the activities and procedure of the works of Irrigation & Waterways Department before taking over the charges of Sub-Division.
