Subject : Approval towards draft Bid Document in connection with the proposed work : "Day to day operation and upkeep of 20 Nos. A+ category of Inspection Bungalows belonging to 1& WD, Government of West Bengal, spread over various districts in the State for a period of 365 days (12 months)"

Reference : His proposal vide No. 738-CI dated 02nd June 2025-

The Irrigation & Waterways Department has taken a holistic approach for management of its assets by constituting an "Estate Management Cell [EMC]" vide Memorandum No. 28-W/2024-25 dt 21st February 2025. One of the objective to constitute this Estate Management Cell is overall management & advisory functioning in matters relating to all lands and assets of the I&W Department as a centralized advisory towards monitoring & supervision of all maintenance, up-keep, manning and allotment of premises viz Inspection Bungalows, Rest Sheds, residential colonies/quarters, offices etc within the I&WD premises.

2. Now, a draft bid document has been prepared by the Estate Management Cell with the following modifications and submitted to this Department for obtaining approval on the following:

- (i) Assigning the Chief Engineer (Design & Research) with the role of accepting authority of the Ll bid in the tender of the related work with power for issuance of LoA as per extant tender rules.
- (ii) According Permission in favour of the Superintending Engineer, Estate Management Cell to float the instant tender in relaxation to I&WD Office Memorandum No. 28-W /2024-25 dated 21/02/2025.
- (iii) Constitution of a four-member Technical Bid Evaluation Committee comprising of CE(D&R) as the Chairman, Superintending Engineer, Estate Management Cell as Member-Secretary, the Executive Engineer, Hooghly Irrigation Division and Executive Engineer, Estate Management Cell being other two members.
- (iv) According approval on the proposal of keeping the PQ credential for the instant work relating to Average Annual Turn-Over as 100% of BoQ value instead of 30% of BoQ, as provision in the Standard E-NIT document of the Department.
- (v) Considering the factor for determination of similar work PQ credential as 0.25 instead of 0.4 as provisioned in Standard E-NIT of the department.
- (vi) Joint Ventures and Consortium are proposed to be disallowed in this tender.
- (vii) The role of Office of the Executive Engineer, Hooghly Irrigation Division under Central Tender Unit may be permitted only for tendering purposes.
- (viii) After finalisation of the tender, the Executive Engineer, Metropolitan Drainage Division No.1 may be designated as the Engineer-in-charge for this work. He will sign the Contract, issue work order and draw bills for payment. EMD & SD are also proposed to be managed by the Executive Engineer, Metropolitan Drainage Division No.1.
- (ix) The concerned Assistant Engineers and Junior Engineers of the custodian divisions of the said 20 No. of Bungalows may be assigned as Estate Officer and Junior Estate Officer of the Division, who would certify the monthly attendance & performance statements of the engaged personnel to the Executive Engineer, Metropolitan Drainage Division No.1 for compilation, billing & payment.
- (x) The Engineer-In-Charge will be at liberty to increase or decrease the Manpower deployment assigned for each or any of the Bungalows based on actual need and even for catering to sudden requirements which may arise in a Bungalow due to VIP movements, commitments or otherwise. This variation shall be maximum up to 25% of the total manpower for this work. Even, the Engineer-in-charge with the approval of the Government may include further bungalows in addition to the 20 Nos. listed here

for manpower deployment with the consent of both the parties. However, revised Expenditure sanction/ approval of the Department is required for all excesses beyond tendered amount as per extant tender rules.

(xi) The Special Terms and Conditions (STC) of the tender notice have also been customized looking into specific need for this work.

3. In view of above, the aforesaid draft Bid Document, as prepared by Estate Management Unit of this Department as submitted vide No. 738-CI dated 02nd June 2025, may be adopted for inviting Bids in this regard.

4. The Department also agrees with the list of 20 nos. A+ category of Inspection Bungalows belonging to I&WD to be included in the scope of instant work and its proposed assigning of Officers, as prepared by the Estate Management Unit and submitted to this Department vide memo under ref.

5. This has an approval of competent authority within this Department.
