<u>ORDER</u>

Two centralised e-procurement 'State Level Help Desks', one at Jalasampad Bhavan, Salt Lake and the other at PWD Guest House at Pranjoli, 3/2 St. Georges Gate Road, Hastings, Kolkata, were established by the State Government with the support of Department of Commerce, Government of India during 2011-12 for monitoring and implementation of e-Procurement as a Mission Mode Project (MMP) under National e-Governance Plan in the States/UTI.

National Informatics Centre (NIC),Gol as the implementing agency of the project had engaged and borne the expenses of eight technical support software personnels (SSP) at the said two Help Desks till 31st May 2016.

However, from 1st June 2016 onwards Department of Commerce, Gol has withdrawn these supports of manpower for the State e-Procurement project.

Considering the continued necessity of such Software Support Personnels for the e-Procurement Project of the State Government, it has been decided in this Department to continue and extend the services of these eight SSP as requested by the State Help Desk of Irrigation & Waterways Department (I&WD) and NIC, Kolkata.

The Governor is now pleased to temporarily appoint on contractual terms the following 8 (eight) Software Support Personnels (SSP) for the 'State Level Help Desks' of e-Procurement for a initial period of 1 (one) year w. e .f 1st June 2016, with a basic monthly Professional Fee of Rs.16,000/- plus yearly increment as applicable.

Since the SSP were already engaged in the project, their consolidated professional fee is notionally fixed after allowing permissible increments on the basis of their completed years of services rendered certified by the Nodal officer of e-tender cell, Irrigation & Waterways Directorate as stood on 01-06-2016 as detailed hereunder:-

It has been further decided that Irrigation & Waterways Department will disburse the 'Professional-Fees' of all the 8 nos. of Software Support Personnels (SSP) including those engaged under the supervision of Public Works Department at Pranjoli after getting the attendance and other related reports.

No further benefits including any arrear claims in this regard would be entertained.

The engagement is purely on temporary contractual basis for a period of one year with provision for further renewal on mutually agreed terms.

The expenditure in connection with payment of professional fees of these 8 no. of Software Support personnel (SSP) is to be borne out of budget of Irrigation & Waterways Department, chargeable to the head of account '2701-80-003-NP-001-28-Payment of Professional & Special Services-02-Other charges-V' as contained in Demand No. 32, B.P No. 20.

Executive Engineer, Metropolitan Electrical Division, Irrigation & Waterways Directorate will act as the DDO for payment of professional fees etc. of the said eight SSP.

Other terms and conditions are guided in terms of Finance Department Memo No. 5859-F(Y) dated 22.07.2013.

This order is issued with the approval of Finance (Audit) Department, Group-T vide their U.O No. Gr.-T/2016-17/0233 dated 11.07.2016.
