**Sub: *Permission to proceed with e-auction through web portal of MSTCL based on the report of the Directorate level Technical Committee for Condemnation of unserviceable Departmental materials for South Bengal Districts.***

**Ref: *Report submitted vide his Memo No. 1229-CI dated 30.03.2017.***

The undersigned is directed to convey the concurrence of this Department for undertaking e-auction through MSTCL on the basis of finalized list of unserviceable departmental materials comprising respective reserve prices and their corresponding (Subject To Approval) STA values fixed by the Directorate level Technical Committee for Condemnation for South Bengal districts.

The reserve price as well as the STA value may be kept strictly confidential in sealed packets under custody of Superintending Engineer in charge of the e-auction, till opening of financial bids so that such data is not disclosed to any body and not even MSTCL at any stage before the e-auction process is fully completed.

After completion of the e-auction and determination of H1 bid, the Superintending Engineer in charge of the e-auction will sale the materials if the H1 bid is equal to or higher than the reserve price. If the H1 bid is lower than the Reserve price, guidelines MSTCL on STA may be followed if deemed fit by the Superintending Engineer maintaining strict confidentiality.

The undersigned is further directed to request him to forward in favour of MSTCL the approved list of materials in hard as well as soft copies without the reserve price and the STA value and finalize the dates for conducting e-auction in consultation with the concerned Superintending Engineers.

The approved list of materials containing the reserve prices and STA value may be handed over maintaining utmost confidentiality to the designated Superintending Engineers only for uploading in the e-auction portal of MSTCL. A copy of Selling Agency Agreement signed between Irrigation & Waterways Department and MSTCL may also be handed over to the Superintending Engineers as a ready reference.

MSTCL shall collect the sale value realized from H1 bidder and after deduction of 3% service charge credit the amount against each auction completed in favour of the concerned Executive Engineer/DDO of Irrigation & Waterways Directorate with supporting bills & vouchers prior to issuance of delivery order.

The Executive Engineers details as well as the Assistant Engineer in charge of Godown with address and contact would be clearly informed to MSTCL to avoid any confusion.

Approval of Finance Department for conducting e-auction through MSTCL has already been communicated to him. This order is issued with the concurrence of Financial Advisor and approval of Principal Secretary of this Department.
