Sub: Additional allocation during 2017-18 under Core State Plan voted Budget for submission of DPRs of 6 no. of identified projects.

The undersigned is directed to say that pursuant to the Departmental Review Meeting held on 06.02.2017, allocation of fund under Core State Plan for taking up new schemes having an aggregate cost of Rs. 725.64 crore comprising financial phasing in 2017-18 of Rs. 190.60 crore has been communicated vide this Department Memo No. 410(7)-IB dated 01.03.2017.

Additional allocation for 13 no. of identified schemes at an aggregate rough cost of Rs. 26.92 crore having financial phasing of Rs. 10.76 crore for this current financial year of 2017-18 was also communicated vide this Department No. 94(2)-IB dated 25.05.2017.

Now, the undersigned is further directed to communicate inclusion of 6 no. of identified schemes under Core State Plan as proposed by him vide his Memo No. 01994-Cl dated 29.05.2017 having aggregate rough cost of Rs. 9.18 crore.
