Agenda: Short listing of additional projects in conformity with approved allocation under Core State Plan budget during the current financial year of 2017-18.

Secretary took the chair. Financial Advisor, Chief Engineer (South) and other officers remained present. The following were discussed:

- Technically sanctioned DPR of 16 new schemes at an aggregate estimated cost of Rs 12.63 Crore were initially placed before the DSC for consideration. Subsequently, two other schemes were placed during the meeting.
- 2. The scheme for undertaking performance tests of pumps at Chowbhaga Pumping Station having cost of Rs 11.98 lakh was set aside, for posing out of maintenance funding.
- 3. All the remaining 17 project details were found to be more or less in order. Only the names of most of the schemes had to be partly modified by the DSC to make them commensurate with the fitment of Plan funding. Chief Engineer was hence requested to modify the names of these projects and re-submit the DPRs for processing for formal Administrative approval. The names of these schemes thus decided in the meeting would only be considered during accordance of formal Administrative approvals and tenders are to be invited accordingly.
- 4. Financial Advisor of the Department requested the Chief Engineer (South) to prepare in due course a work done revised estimate inclusive of the various ancillary projects which are separately sanctioned in connection with originally approved Beautification work of Kestopur Canal in between 0.00 km to 2.00 km, in conformity with the provisions contained in the WBFR.
- 5. Chief Engineer (South) stated that the scheme for special repair to 4 No. steel foot bridges over Kestopur Canal originally approved in this FY bearing ID No. IW/CSP-58/2017-18 for Rs 32.79 lakh communicated vide Departmental order No. 44-IB dated 3.5.2017 may be cancelled and fresh DPR of scheme at an estimated cost of Rs 92.30 lakh (SI. 14 of the Annexure to this order) be considered as a

replacement. Due to advertency important subcomponent items were not included in the original estimate and as such tender could not be invited with old estimate.

- 6. Chief Engineer (South) certified that there is no duplication of proposals with other sources of funding. All the schemes have been selected on the basis of prioritised ground requirements within approved allocation.
- 7. Finally 17 no. of schemes at an aggregate cost of Rs. 14.49 crore were cleared by the DSC for inclusion under Core State Plan Budget of this Department during the current financial year of 2017-18.
- 8. Tenders may be invited immediately.
