ORDER

The Governor has been pleased to accord permission in terms of Rule 5(2) of W.B.S.(Duties, Rights & Obligations of Govt. Employees) Rules,1980 read with No.1853-F(P) dt.2.3.12 in favour of Sri Kaushik Sarkar, Assistant Engineer, Damodar Canal Head Quarters Sub-Division, Irrigation & Waterways Directorate to acquire a residential flat measuring 1065 sq. ft. as super built up area with additional 115 sq. ft as car parking area , at the cost of **Rs.36,50,000/- (Rupees Thirty Six Lakh Fifty Thousand) only** with additional quantum of **Rs.2,59,291/- (Rupees Two Lakh Fifty Nine Thousand Two Hundred Ninety One) only** as proportionate registration fee etc, tantamounting to **Rs.39,09,291/- (Rupees Thirty Nine Lakh Nine Thousand Two Hundred Ninety One) only** , at 86, Thakurpara Road, P.O. Purba Putiary, P.S.-Regent Park, Ward No.114 under Kolkata Municipal Corporation.

The permission is hereby accorded subject to the condition that securing compliance of all statutory duties, liabilities and obligations as enshrined under the provisions of the West Bengal Apartment Ownership Act'1971 and/or West Bengal (Regulation of Promotion of Construction and Transfer by Promoters)Act,1983 and rules framed there under as amended time to time and also any other rules/statutes that may be applied to him in this context will be his sole responsibility and Government in no way will be responsible for violation or deviation of non-observance of such rules.

This order is issued subject to the condition that Sri Sarkar will remain answerable to the Govt. if any of the furnished facts/documents is found to be false/ incorrect in later date.

The said property should have been reflected in returning of declaration of asset.
