were debarred/suspended to participate in the tenders of I & W Directorate Govt. of West Bengal for the next 02 (Two) years with effect from 21st March 2016 vide this office memo no. 180/1-C.I(N) dt. 21/03/2016. Further an amount of Rs. 169438/- (Rupees one Lakh sixty nine thousand four hundred thirty eight) only as earnest money was forfeited to the Government as submitted by MAA BOLLA KALI CONSTRUCTION.

have prayed for reconsideration of debarment imposed upon them and withdrawal of the same. Superintending Engineer North Irrigation Circle-I submitted the prayers of the above agencies to Chief Engineer (North), I&W Directorate, Govt. of West Bengal vide his memo no. 678 dt. 13/07/2017 and Chief Engineer (North) I&W Directorate, Govt. of West Bengal upon receipt of the same instructed Superintending Engineer North Irrigation Circle-I, to convene a meeting of Departmental Tender Committee (DTC) for South Bengal on the instant issue. The Departmental Tender Committee (DTC) for South Bengal sat on 20/07/2017 and discussed that as per the memorandum issued by I& W Department vide their No. 03-W/2017-18 Dt. 18052017, the offence committed by the agencies falls on First Degree category which provides penal measures of forfeiture of earnest money and debarment from participating in all the Tender of I& W Department for a period of Six months. The agencies who have prayed for lifting of the debarment from participating in all the Tender of I& W Department have already completed the said period and earnest money of the participating agency 'MAA BOLLA KALI CONSTRUCTION' has already been forfeited.
