**ORDER**

The Governor has been pleased to accord permission in terms of Rule 5(2) of W.B.S.(Duties, Rights & Obligations of Govt. Employees) Rules,1980 read with No.1853-F(P) dt.2.3.12 in favour of Sri Sujit Kumar Das, Assistant Engineer, Ganga Anti-Erosion Sub-Divn. No.-V, Irrigation & Waterways Directorate to acquire a residential flat measuring 986 sq. ft. of super built area for residential purpose in an under construction housing project at the premises at 77/1, Alepkhan Mahalla Road, within Berhampore Municipality, R.S. No.1735, 1738, L.R. No.2937, 2941, J.L. No.91 at Mouza- Gorabazar, P.S.-Berhampore, at the consideration price of **Rs.19,50,000/- (Rupees Nineteen Lakh Fifty Thousand ) only** with proportionate cost of Govt. duty as applicable tantamounting to **Rs.22,75,600/- (Rupees Twenty Two Lakh Seventy Five Thousand Six Hundred) only**.

The permission is hereby accorded subject to the condition that securing compliance of all statutory duties, liabilities and obligations as enshrined under the provisions of the West Bengal Apartment Ownership Act'1971 and /or West Bengal (Regulation of Promotion of Construction and Transfer by Promoters) Act,1983 and rules framed there under as amended time to time and also any other rules/statues that may be applied to him in this context will be his sole responsibility and Government in no way will be responsible for violation or deviation of non-observance of such rules.

This order is issued subject to the condition that Sri Das will remain answerable to the Govt. if any of the furnished facts/documents is found to be false/incorrect in later date.

The said property should have been reflected in returning of declaration of asset.
