**‘Records of discussion’ of the meeting of “Departmental Screening Committee” held on 21.12.2017 at the Ground Floor of Conference Hall at Jalasampad Bhavan, Salt Lake.**

**Agenda:** Short listing of additional projects for inclusion under Core State Plan voted budget during the current financial year of 2017-18.

Secretary took the chair. Financial Advisor, Chief Engineer (South), Chief Engineer (South West), Chief Engineer (West) and other officers remained present.

The following were discussed:

1. Technically sanctioned DPR of 8 (eight) schemes at an aggregate estimated cost of Rs 38.98 crore were placed before the DSC for consideration.
2. Out of above, 5 no. of the schemes were in jurisdiction of Chief Engineer (South West) which were also previously discussed in the DSC meeting held on 11<sup>th</sup> September, 2017 but returned for rectifications. The remaining 3 (three) schemes comprise prioritised projects involving gate replacement of Durgapur Barrage, Procurement & installation of Pumps at newly proposed Uttarbhadra PS whose civil work is almost complete, and the interior renovation civil works of Jalasampad Bhawan.

3. The DPR for remodelling of Ground Floor upto 3<sup>rd</sup> Floor at a cost of Rs. 997.36 lakh contains only interior civil works & furniture/goods procurement etc. However the DPR for electrical work should be taken up and executed simultaneously so that the embedded components of electrical parts & wiring etc and the fire fighting concealed components may be completed before proceeding with the finishing work/items of civil portion. However, the scheme for civil work placed before the committee was cleared with a direction to place the remaining works before the DSC at an early date and abide by the directives.
4. The process for preparation of estimate for supply and installation of heavy duty pumps at the Additional Uttarbhadra Pumping Station was explained to the committee by the Chief Engineer (South) and the Superintending Engineer, Mechanical & Electrical Circle. The scheme was cleared by the committee.
5. 5 no. of schemes are within jurisdiction of Chief Engineer (South West) were placed in the DSC meeting after incorporating all necessary corrections as directed in the DSC meeting held on 11.09.2017. Only the words 'Ex-Zamindari Embankment' was inserted in the nomenclature of the scheme listed at sl. 4.
6. It was further discussed that estimate for emergent replacement of damaged under sluice gate and fabrication of two new gates as standby have been framed based on detailed rate analysis after thorough assessment and verification. The project should be immediately tendered with 14 days bid submission period (SNIT), for which a formal proposal of Chief Engineer (West) needs to be sent to Finance Department.
7. All the Chief Engineers certified that there are no duplication of proposals with any other sources of funding, and all the schemes have been selected by them on the basis of prioritised ground requirements.
8. Finally all the 8 no. of schemes at an aggregate cost of Rs. 38.98 crore were cleared for inclusion under Core State Plan Budget of this Department during the current financial year of 2017-18.
9. It was directed by the Chairman of the Departmental Screening Committee that henceforth in all DSC meetings, the concerned Chief Engineers who places any proposal for consideration himself being the members of DSC (SE or EE are only invitees) should invariably remain present to explain their cases before the Committee.
10. Tenders for all the 8 schemes cleared may be invited.
