No. 926/98 U/s 420/418/409/406/409/34/477A/34/120B of the I.P.C. and after examination of reports of District Magistrate, Jalpaiguri, Divisional Commissioner of Jalpaiguri Division, Superintendent of police, Jalpaiguri and also considering the reports of District P.P., Jalpaiguri and valued opinion of Ld L.R., W.B., has considered on summum bonum and further scope on matter of exonerations of the accused officer Sri Gurudas Chakraborty, Ex-EE since retired;

Whereas, this Administrative Department has issued order no.1285-IE Dt.8.5.2015 and exonerated Sri Chakraborty from the charge levelled against him under the Departmental Proceedings drawn up vide Memorandum No.121-IE(V) Dtd.23.11.1998, giving effect on payment of all admissible pensionary benefits to Sri Gurudas Chakraborty, Ex-Executive Engineer, as per his entitlement as on date of his retirement on 31.01.2007,

AND

Whereas, it is reported that the payment of leave encashment equivalent to unutilised Earned Leave as credited in the leave account of said Sri Chakraborty, was given an objection by Berhampore Treasury-II, on the analogy of rules & regulation as enshrined in Rule 4.024 of W.B.T.R., and such dalay in submitting the same is beyond administrative control due to pendency of criminal case as aforesaid, at judicial forum.

Now, therefore, the Governor is hereby pleased to condone the delayed period which is more than six years and the undersigned, by the order of the Governor, is directed to say that the undrawn amount of leave salary as admissible, may be released in favour of Sri Chakraborty.
