Sub: Submission of indents up to March 2018 for allotment of fund under Core sector and RIDF in respect of spill over ongoing schemes.

The undersigned is directed to request him to instruct the concerned Superintending Engineers and Executive Engineers under his control to submit anticipated scheme wise requirement of further fund for the last quarter of this financial year at one go targeted to be utilised within 31st March 2018 against all spill over ongoing schemes approved under Core Plan and NABARD assisted programme in 2014-15, 2015-16 and 2016-17.

It is pertinent to state that most of the above mentioned projects administratively approved under Core State Plan and RIDF during the FY of 2014-15, 2015-16 and 2016-17 are more or less physically completed or would be completed before the end of current FY. The approved financial phasing/sanction for such schemes also expires on 31st March 2018.

These indents are required at the earliest as because upon receipt of entire individual scheme wise indents, these proposals would be processed in most cases for relaxation of head wise ceiling limits fixed by the Finance Department or for affecting re-appropriation which will consume substantial time. In the absence of such indents it might be difficult to process huge number of re-appropriations at the fag end of the FY and also hamper the new work planning.

In the above context, the undersigned is directed to request him to ensure that the entire scheme wise (with ID no) anticipated fund requirement for Core State Plan and RIDF, tranche-XVII to XXII anticipated to be expended till 31st March 2018 in prescribed Format-A or Format-P is to be sent through e-mail, fax or hard copy to the undersigned within 19th January 2018.

This may please be treated as most urgent.
