ORDER

7	Prayer for transfer of Circle Cadre staff from jurisdiction of one Chief Engineer to another.	Concerned Chief Engineer shall recommend to Director of Personnel and Ex-Officio Chief Engineer for issuance of transfer order.
8	Transfer of Muster Roll/ Contingent/ Casual/ Part-time/ Daily rated/ Contractual staff within jurisdiction of same Chief Engineer.	Concerned Chief Engineer shall issue transfer order.
