ORDER

Whereas, vide Notification No. 53-IE & 54-IE dated 17th July, 2017 of this Department amendments have been made in the rules for regulation of recruitment to the Engineering services under the Irrigation & Waterways Department published under this Department in 'Part-I-Cadre' for Rules 3 of Notification No. 24 & 25 dated 16th February, 1989, wherein by abolishing the previous three services namely a) West Bengal Senior Services of Engineers (Irrigation) b) West Bengal Services of Engineers (Irrigation) c) West Bengal Subordinate Engineering Services (Irrigation), only two services have been created namely a) West Bengal Engineering Service (Irrigation) consisting of the post of Secretary, posts of Chief Engineers (both in the Civil Engineering wings only), Superintending Engineers, Civil (including the posts which are designated as Director), Executive Engineers, Civil (including the posts which are designated as Technical Assistant to the Superintending Engineers and Chief Engineers, Deputy Directors) and Assistant Engineers, Civil (including the posts which are designated as Assistant Director) and simultaneously, West Bengal Engineering Service (Mechanical & Electrical) consisting of the posts of Superintending Engineers (Mechanical & Electrical), Executive Engineers (Mechanical & Electrical) (including the posts which are designated as Deputy Director) and Assistant Engineer (Mechanical & Electrical) (including the posts which are designated as Assistant Director).

And

Whereas, the prevailing rule of filing up vacant post of Executive Engineers (Civil) & (Mechanical & Electrical) the erstwhile cadre of West Bengal Senior Service of Engineers under this Department was through promotion from eligible permanent Assistant Engineers (Civil) & (Mechanical & Electrical) only after having been recommended by Public Service Commission, West Bengal.

And

Whereas, in view of above said previous two cadres namely a) West Bengal Senior Services of Engineers (Irrigation) b) West Bengal Services of Engineers (Irrigation) have now been merged in one cadre namely 'West Bengal Engineering Service'. Hence, for filing up vacant posts of Executive Engineers (Civil) & (Mechanical & Electrical) through promotion from eligible permanent Assistant Engineers (Civil) & (Mechanical & Electrical), Public Service Commission of West Bengal's recommendation is not required.

Now, in view of above, the Governor is hereby pleased to constitute a Departmental Promotional Committee under this Department with the following officers of this Department, who will recommend the name of eligible permanent Assistant Engineers (Civil) & (Mechanical & Electrical) as per norms for promotion for the post of Executive Engineers (Civil) & (Mechanical & Electrical) under this Department.
