ORDER

Whereas, a Debarment Order was issued by this Department vide No.14-W/2017-18 Dt.29.08.2017, debarring agency Niyati Construction, from participation in all types I&WD tenders for a period for 6 (six months) period effecting from 30.06.2017 as well as to restrain the said agency i.e. Niyati Construction from using the work credential (completion certificate) for the three works in which the said agency was alleged to adopt wrongful & fraudulent practice,

AND

Whereas, said agency has prayed for sympathetic consideration of authorities of Irrigation & Waterways Department, for withdrawal of aforementioned two impositions prevailing on, on the humanitarian ground, to give leverage to the workers dependent on the said agency for their bread and butter, and it may be considered in quite justification that imposition of using credential would not permit the said agency even after expiry of debarment period, to take effective participation in tendering procedure causing a severely difficulty to keep smooth flow of fund for maintaining the livelihood of workers & staffs of the said agency,

Now, after careful consideration of all the entire issue and keeping in mind, the sincerity in service and successful completion of work as accomplished by Niyati Construction and debarment of its credential of the said three works in question, might have been incapacitated it seriously from being able to be qualified as successful tendered in future due to insufficient credential for which not only the Agency but also the livelihood of the workers associated with the agency would suffer, the undersigned is directed by the Governor to say that the Governor has been pleased to relax the period of restriction, to 6 (six) months during period from **30.06.2017 to 28.02.2018**, instead of permanent nature, in lieu of terms & conditions of para-2 of imposition of penalties in Order No.14-W/2017-18 Dt.29.08.2017, for using the credential of three works as detailed herein under :

1. e-NIT WBIW/SE/GCDC/NIT-20(e) /2014-15, SI No.1 of Greater Calcutta Drainage Circle.
2. e-NIT WBIW/SE/WC/NIT-09(e) /2015-16, SI No.1 of Western Circle.
3. e-NIT WBIW/SE/EC/NIT-16(e) /2014-15, SI No.3 of Eastern Circle.

This order is being issued in partial modification of this Department's Order No.14-W/2017-18 Dt.29.08.2017.
