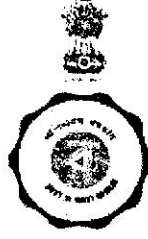

Corrigendum to Office Order No-289-I/I-4M-43/13 dated 09.08.2018

The Department took a special step to introduce detailed examination and scrutiny of the completed and ongoing plan works by constituting 10 separate teams of Departmental Officers (Technical Examination Teams) for conducting technical audit at different zones across the State vide department's order no-29 (W)/2016-17 09.11.2016. The basic objective was to examine a plan scheme, starting from its planning to its complete execution and to check if the prescribed rules in making payment, transparency in tendering, quality checking during examination and adequate field investigation during planning stage to avoid overlap of zone of works, have been strictly adhered to.

Recently a good number of plan schemes are being executed by the Executive Engineer, Kangsabati Canal Division-II relating to either improvement of canal system of Kangsabati Reservoir Project or Rehabilitation of existing minor irrigation schemes. Providing canal lining, repair of appurtenant structures are the main components of such works. The Department has recently brought out a guideline for selection of specification of canal lining in a particular zone for strict compliance. Some other schemes relating to irrigation improvement are in the pipeline by execution of the aforesaid division. Immediate Technical Audit of the plan schemes of Kangsabati Canal Division-II by a suitable team already constituted would be the most appropriate step to

examine if proper planning, fairness and transparency and appropriate quality have been maintained in implementation of the plan schemes of the said division.

In view of above, and in partial modification to the Departmental order no-289-I/I-4M-43/13 dated 09.08.2018 the undersigned is directed to inform that the following TET will be conducting the technical audit of the plan schemes of Kangsabati Canal Division-II with special emphasis on the under mentioned two schemes abiding by the procedures set forth in the Department's order No-29(W)/2016-17 dated 09.11.2016, in lieu of the team-7 under the Superintending Engineer/Western Circle-I.

A. TET for Kangsabati Canal Division-II

B. Special emphasis are to be given on two schemes:

- i. Nandaranga Minor Irrigation Scheme
- ii. Mahadebsinan Irrigation Scheme

Apart from the scope of examination, laid down in the Department's Order no-29(W)/2016-17 dated 09.11.2016, the TET, in the instant case will also examine if any overlap of the plan schemes with the Non Plan schemes executed in last 3 years have taken place.

The TET will submit its report to the Chief Engineer (South-West) by 15.09.2018, who in turn will submit his report to the Department by 30.09.2018.
