The concerned Executive Engineers also remained present.

Agenda: Recommendation for 53 new schemes for accordance of administrative approval under State Development Schemes Budget of this Department during 2018-19 out of 2nd phase of Departmental allocation for 2018-19 and special funding approved under Infrastructure Gap.

Secretary took the chair. Financial Advisor, Chief Engineer (South West), Chief Engineer (South), Chief Engineer (North), Chief Engineer (Design & Research), Chief Engineer (West) and other officers remained present.

The following were discussed:

- 1. Technically sanctioned DPR of 53 no. new schemes including 3 Infrastructure Gap Funded schemes at an aggregate cost of Rs. 170.50 crore were initially placed before the committee.
- 2. Out of a total of 27 Medium Irrigation schemes proposed under Infrastructure Gap funding 16 schemes have been cleared previously and 3 more were discussed in this meeting.
- 3. After a detailed scrutiny of DPRs in the meeting, the following observations were made by the DSC:
 - Scheme listed at SI. No. 1 dropped, due to the estimate having been framed based on old SoR.
 - ii. Scheme listed at Sl. No. 2 dropped, as the sub base of the road provided with moorum which was advised to be replaced by jhama consolidation.
 - iii. Sl. No. 3, 19, 20 cleared subject to correction of 'Over head' charges as per PWD SoR.
 - iv. Schemes listed at Sl. No. 9, 10, 12, 14, 15, 28 & 31 cleared, subject to rectification of the shuttering rates of toe walls and furnishing of mandatory certificates as per FA guideline.
 - v. Scheme listed at Sl. No. 21 dropped as vetting of Central Design Office is required.
 - vi. Schemes listed at Sl. No. 25, 26, 27 cleared subject to recast of sand filling below lining for 50 mm and grade of PCC changed to M-20.
 - vii. Schemes listed at Sl. No. 30, 33, 36 dropped.
 - viii. Scheme listed at Sl. No. 38 dropped, as the entire reach is to be executing adopting same methodology i.e wet excavation.
 - ix. Schemes listed at Sl. No. 45, 46, 47, 49 cleared. However, it is to be justified with technical notes the reasons for deviation from Departmental Manual.
- 4. After a threadbare discussion 36 No. of schemes at an aggregate cost of Rs. 74.45 crore were recommended by the DSC for accordance of administrative approval.

5. Further 3 No. of schemes at an aggregate cost of Rs. 15.78 crore were cleared under Infrastructure Gap funding (Annexure-II) which shall involve partial funding out of Departmental (Voted) Budget and the balance cost to be made out of Infrastructure Gap funding in addition to original voted provisions.

6. Nomenclature of a few schemes was modified to make them commensurate with the capital works and some minor corrections were incorporated.

7. All the Chief Engineers certified that there is no duplication of proposal with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.

8. Finally 39 (thirty nine) no. of new schemes at an aggregate cost of Rs. 90.23 crore were cleared by the DSC (comprising 36 no. of schemes at a cost of Rs. 74.45 crore at Annexure-I and 3 no. of schemes at an aggregate cost of Rs. 15.78 crore at Annexure-II) for inclusion under State Development Schemes Budget and special allocation against approved projects of Infrastructure Gap funding.

The meeting ended with vote of thanks.
