MEMORANDUM

WAPCOS Limited, a Government of India Enterprise has been engaged by the Irrigation & Waterways Department w.e.f. 30.08.2017 for conducting Safety Audit for structures owned and maintained by Irrigation & Waterway Department, Govt. of West Bengal for all categories of dams, barrages including pick up barrages and major category RCC / Steel / Composite Bridges. The work is in full swing and expected to be completed within the schedule time i.e. 29.10.2018. As a part of their scope of work preliminary reports/recommendations have been submitted by the WAPCOS Limited suggesting immediate restoration of some bridges, barrages and special repair to dams in Purulia. The final WAPCOS report is expected by the end of October-2018.

2. It has been decided in the review meeting of the Additional Chief Secretary, I&WD on 19.07.2018 to constitute a Departmental Committee to finalise the work programme on rehabilitation / reconstruction/special repair of important structures based on the suggestions/recommendations that have already been communicated in the preliminary reports or would be communicated in their final report by WAPCOS Ltd.

3. Terms of Reference:-

- I. The Committee will examine the preliminary reports already submitted by the WAPCOS Limited and finalise the specification and work plan of those structures which have been specifically mentioned therein for taking up rehabilitation after the monsoon of 2018. The Committee will submit its report to the Department within a period of one month from issue of this order.
- II. The Committee will also examine the final report of WAPCOS Ltd, once it is made available to the Department in the 1st week of November-2018. A comprehensive plan of rehabilitation and special repair of the identified distressed dams, barrages, structures etc will be drawn up by the Committee mentioning the time line and rough cost estimates for such rehabilitation works. The said work plan will be finalised by 15.12.2018.
