The concerned Executive Engineers also remained present.

Agenda: Recommendation of new schemes for accordance of administrative approval under State Development Schemes Budget of this Department during 2018-19 out of 2nd phase of Departmental allocation for 2018-19.

Secretary took the chair. Financial Advisor, Chief Engineer (South), Chief Engineer (North), Chief Engineer (South West) and other officers remained present.

The following were discussed:

1. Technically sanctioned DPR of 45 no. new schemes at an aggregate cost of Rs. 102.95 crore were initially placed for approval. Further 9 schemes at an aggregate cost of Rs 89.59 crore relating to Special Infrastructure funding were also placed before the committee.
2. The DSC scrutinized all the DPRs' in conformity with the Departmental manuals for lining works and those for bank protection works.
3. After a threadbare discussion 41 No. of schemes at an aggregate cost of Rs. 100.74 crore were recommended by the DSC for accordance of administrative approval under State Development Schemes budget provisions of 2018-19 under Phase-II allocation (Annexure-I).
4. Further 9 No. of schemes at an aggregate cost of Rs. 81.59 crore comprising 9 Medium & Minor Irrigation schemes in the Districts of Purulia, Jhargram and Burdwan were cleared under Special Infrastructure funding (Annexure-II).
5. Nomenclature of a few schemes was modified to make them commensurate with the capital works and some minor corrections were incorporated.
6. Schemes under Sl. 22 to 25 involving Berhampore Irrigation Division was approved on the condition that the Superintending Engineer shall reduce the depth of apron from 0.9 m to 0.60 m keeping the volume per meter same. Regarding scheme under Sl. No. 26 work should be done over two financial years, slope stabilization in the first year and protection work in the next financial year.

7. All the Chief Engineers certified that there is no duplication of proposal with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
8. Finally 50 (fifty) no. of new schemes at an aggregate cost of Rs. 182.33 crore were cleared by the DSC (comprising 41 no. of schemes at a cost of Rs. 100.74 crore at Annexure-I and 9 no. of schemes at an aggregate cost of Rs. 81.59 crore at Annexure-II) for inclusion under State Development Schemes Budget and special allocation against approved projects of Infrastructure Gap funding.
9. Tenders are to be invited immediately.


