***Sub: Approval towards engagement of an Agency on the basis of H1 bid price in auction for 'Guarding, Operating & Maintenance of Mahananda Barrage Park at Fulbari in the District Jalpaiguri and Darjeeling' for a period of 1 (one) year on a pilot project basis.***

With reference to his proposal vide Memo No. 630-CI(T)/11C-01/18 dated 20.08.2018, the undersigned is directed to say that the Governor has been pleased to accord approval towards engagement of 'Mahananda Security Service' for 'Guarding, Operating & Maintenance of Mahananda Barrage Park at Fulbari in the Districts Jalpaiguri and Darjeeling' for an initial period of 1 (one) year on a pilot project basis upon depositing H1 bid price of Rs. 70,000.00 (Rupees seventy thousand only) payable to the Government subject to compliance of the following conditions:

1. The engagement is approved for 1 (one) year only on a pilot project basis,
2. After this one year fresh bid will have to be invited after fixation of Reserve Price on the basis of data found available from the receipt books or records etc.

He is requested to direct the concerned Executive Engineer to deposit the amount of Rs 70,000/ under the Government revenue receipt head 0700-01-104-001-27.

This order issues with the concurrence of Financial Advisor, Irrigation & Waterways Department vide his U.O No. 241 dated 27.09.2018.

Concerned Superintending Engineer and Executive Engineer may please be kept apprised from his end. An Agreement to this effect is to be executed between the Agency and the Superintending Engineer, Mahananda Barrage Circle; Irrigation & Waterways Directorate prepared by him and got vetted from the Ld Government Pleader of the district.
